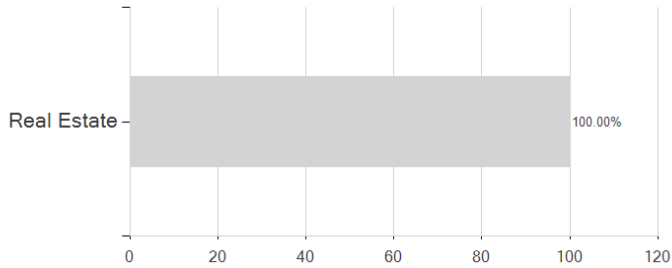

Investment goal

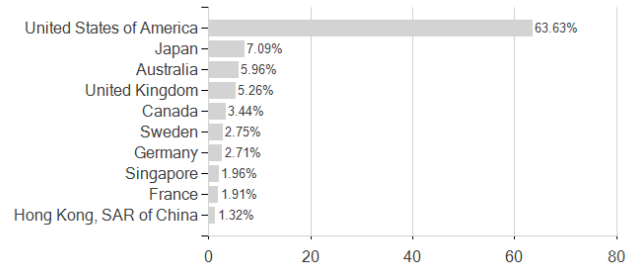

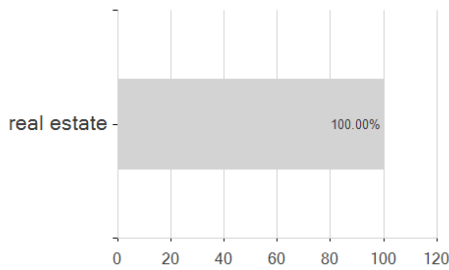

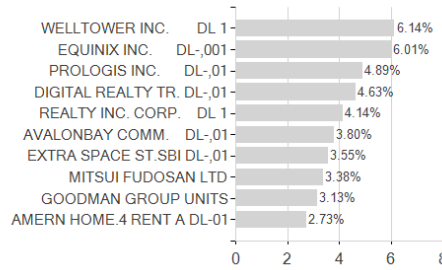
