OBJECTIVES AND INVESTMENT POLICY

Investment objective

The Fund seeks to increase the value of your investment over time through a combination of capital growth and income (total return).

Investment policy

Under normal market conditions, the Fund typically invests in equity securities and debt securities of any credit quality of issuers that are organised, or have substantial business activities, in the US. These issuers may be of any market capitalisation and industry.

The Fund may also seek exposure to other asset classes such as commodities, real estate, currencies, interest rates, and call and put options, as well as to eligible indices. The Fund is not limited in its exposure to equities, debt securities or currencies. The Fund expects to invest through other UCITS and ETFs to gain exposure to certain asset classes permitted by this investment policy.

The Fund may invest in or be exposed up to (i) 40% in debt securities rated below Investment Grade, (ii) 20% in structured products such as asset-backed and mortgage-back securities, and (iii) 20% in contingent convertible bonds (CoCos).

The Fund may be exposed to any currency.

The Fund is not subject to the 10% limits for investments in UCITS and other UCIs (including eligible ETFs).

The Fund uses derivatives to a significant extent for hedging (reducing risks), efficient portfolio management and other investment purposes (including to gain additional exposure).

Responsible Investing

The Fund is classified as Article 8 under SFDR. For more information, please refer to sustainability-related disclosures in the prospectus.

Benchmark

The Fund is actively managed and its investments are not made in any reference to any benchmark.

Hedged share class

This share class seeks to reduce the effect of exchange rate fluctuations between the Fund's base currency and the currency of the share class.

Fund currency

The reference currency of the Fund is USD.

Share class currency

The reference currency of the share class is AUD.

Distribution policy

This share class is a distributing share class. Dividends may include income, realized capital gains and/or be paid out of capital.

Redemption

Shares may be redeemed on any day when both the New York Stock Exchange and Luxembourg banks are open for business.

Terms to understand

Asset-backed securities: Debt securities representing an interest in a pool of consumer debt, such as credit card debt or automobile loans.

Below Investment Grade Securities: Debt securities rated below Investment Grade that may be higher-yielding but riskier debt securities.

Contingent convertible bonds ("CoCos"): CoCos are a type of contingent security issued by global financial institutions. CoCos are usually subordinated and convert to the issuer's equity and/or have a write-down following the occurrence of a pre-determined event.

Debt securities: Securities that represent the obligation to pay a debt, with interest.

Derivatives: Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

Equities: Securities that represent an ownership stake in a company.

ETFs: An exchange traded fund that qualifies as UCITS or eligible UCI within the meaning of Article 41(1)(e) of the law of 17 December 2010 on undertakings for collective investment, as amended.

Investment Grade Securities: Debt securities rated at or above BBB-/Baa3.

Mortgage-related securities: Debt securities representing an interest in a pool of mortgages.

SFDR: Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector.

UCITS: An undertaking for collective investment in transferable securities that comply with the law of 17 December 2010 on undertakings for collective investment, as amended.

RISK AND REWARD PROFILE



What does this risk indicator mean?

This synthetic risk and reward indicator (SRRI) scale rating indicates how the Fund may perform and the risk of losing some or all of your capital. Generally the potential for higher gains also means a larger risk of losses. The lowest category does not mean a risk free investment.

Why is this Fund in this category?

The Fund is not guaranteed in capital. The Fund is invested in equity securities that can face sharp variations up or down and that can generate significant gains or losses.

Risks materially relevant to the Fund but not adequately captured by the SRRI:

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

Allocation risk: The Fund's allocation to various asset classes may change over time and this could impact the performance of the Fund positively or negatively.

Counterparty risk: If an entity with which the Fund does business becomes insolvent, payments owed to the Fund could be delayed, reduced, or eliminated.

Liquidity risk: Certain securities could become hard to buy or to sell at a desired time or price.

CHARGES

The charges you pay are used to pay the cost of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

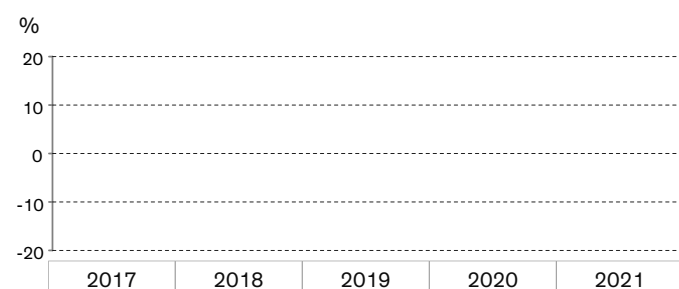
