OBJECTIVES AND INVESTMENT POLICY

Investment objective

The Fund seeks to increase the value of your investment over time through capital growth, while seeking significantly lower carbon exposure than global equity markets (as measured by the MSCI World Index).

Investment policy

Under normal market conditions, the Fund typically invests in equity securities of companies anywhere in the world, including in emerging market countries, that the Investment Manager believes have lower aggregate carbon exposure. These companies may be of any market capitalization and industry.

The Fund may invest on or be exposed to up to 30% in equity securities of emerging market countries.

The Investment Manager seeks to select securities that it believes are high quality, have reasonable valuations and offer attractive Shareholder returns.

As part of the Investment Manager's investment process, when constructing the portfolio of companies with aggregate carbon exposure that is significantly lower (at least 50%) than the carbon exposure of the MSCI World Index, the Investment Manager also integrates factors such as companies' carbon footprint, the overall carbon reduction strategy, including specific climate targets, proven reductions, and green revenues in view of the global efforts to transition to a lower carbon economy. It also considers other environmental and/or social criteria that might affect companies' performance.

The Fund may be exposed to any currency.

The Fund uses derivatives for hedging (reducing risks), efficient portfolio management and other investment purposes.

Responsible Investing

The Fund is classified as Article 8 under SFDR. For more information, please refer to sustainability-related disclosures in the prospectus.

Benchmark

MSCI World Index used for performance comparison and carbon exposure measurement.

The Fund is actively managed and the Investment Manager is not constrained by its benchmark. Please see the Fund's prospectus for more information.

Fund currency

The reference currency of the Fund is USD.

Share class currency

The reference currency of the share class is GBP.

Distribution policy

This share class is a non-distributing share class. Income and capital gains derived from the Fund are reinvested.

Redemption

Shares may be redeemed on any day when both the New York Stock Exchange and Luxembourg banks are open for business.

Terms to understand

Derivatives: Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

Equities: Securities that represent an ownership stake in a company.

Emerging market countries: Nations whose economies and securities markets are less established.

Other investment purposes: In line with the Fund's investment objective and policy, means to gain exposure.

What does this risk indicator mean?
