What is this product?

Type

This product is an investment fund.

Term

The Fund is established for an unlimited duration, with the possibility for the Board of Directors to decide the termination of the Fund at its sole discretion.

Objectives

Walter Scott European ESG Equities belongs to the category of Single Manager Funds.

The Fund seeks to increase the value of its assets over the long term by investing predominantly in transferable equity securities such as equities, other equity shares such as co-operative shares and participation certificates issued by, or warrants on transferable equity securities of, companies which are domiciled in or exercise the predominant part of their economic activity in Europe.

The minimum asset allocation in such securities on a consolidated basis (direct and indirect investments) will be of 60% of the Fund's net assets

Moreover, the minimum sub-fund's investment in equity securities will be of 75% of the Fund's net assets.

The sub-fund may invest up to 20% in bank deposits at sight, including cash held in current accounts with a bank accessible at any time.

The Fund may invest for maximum 10% of its net assets in funds that have been selected in accordance with a number of qualitative and quantitative criteria.

Sustainable Investment Policy The Fund promotes environmental and social characteristics and qualifies as an investment product in accordance with article 8(1) of Regulation (EU) 2019/2088 on sustainability related disclosures in the financial services sector as set out in Book I.

In that respect, the eligible universe is determined by the following criteria:

• Exclusion filters: the purpose of these filters is to exclude companies and activities from the initial universe that might a have negative effect on society and environment or human rights (activities based and normbased exclusions). On this basis, are excluded certain controversial sectors such as but not limited: weapons, tobacco producers and sellers, GMOs, alcohol production, gambling, adult entertainment, artic

drilling, shale gas, oil sands, coal mining, etc. The External Investment Manager should therefore be compliant with the exclusions rules of the Sustainable Investment Policy of the Management Company (as per Book I of the prospectus) and may apply additional exclusions from his own core sustainable investment policy.

 An ESG framework using proprietary ESG metrics such as fundamental ESG ratings and investment ESG scores to identify the issuers.

The ESG selection process (exclusions and ESG screenings) will result in removing from investments at least 20% of the initial universe as these investments do not have an ESG rating from MSCI (exclusions, level of ESG ratings). For any companies not evaluated by MSCI but which otherwise meet the firm's criteria, the External Investment Manager will consider its own internal ESG research in determining whether the holding is suitable for inclusion. While not quantified, a number of other companies are also excluded based on economic activity and norm-based exclusion restrictions.

The extra-financial analysis covers at least 90% of the portfolio.

The derivative instruments are not covered by the ESG analysis.

Relation to the Reference Portfolio This Fund is actively managed and is compared to the MSCI Europe TR Net for performance and risk level indicator purposes. However, the reference to this index does not constitute any objective or limitation in the management and composition of the portfolio and the Fund does not restrain its universe to the index components. The index does not evaluate or include its constituents on the basis of environmental and/or social characteristics and is therefore not aligned with the ESG characteristics promoted by the Fund.

Therefore returns may deviate materially from the performance of the reference index.

The base currency of the Fund is EUR.

Income is systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

Risks

What happens if ABN AMRO Funds Walter Scott European ESG Equities is unable to pay out?
