## What is this product?

### Type

Macro Fixed Income Fund (the "Fund") is a Sterling denominated sub-fund of a SICAV (société d'investissement à capital variable), abrdrn SICAV II, incorporated in Luxembourg.

### Term

abrdrn SICAV II (the "Company") has no maturity date. The Fund and the Company may not be unilaterally terminated by abrdrn Investments Luxembourg S.A.

### Objective

The Fund aims to achieve a combination of income and growth by investing in a diversified portfolio of bonds (both investment grade and sub-investment grade) from across the global fixed income universe, in both developed and emerging markets.

The Fund aims to exceed the return on cash deposits by 3% per annum, evaluated over rolling three-year periods (before charges).

SONIA has been chosen as a proxy for the return on cash deposits.

### Portfolio Securities

- The Fund uses a combination of traditional assets (such as bonds, cash and money market instruments) and investment strategies based on derivative techniques, resulting in a highly diversified portfolio.

- The Fund can take long and short positions in markets, securities and groups of securities through derivative contracts.

- The Fund may also invest in other Funds (including those managed by abrdrn), money-market instruments, and cash.

### Management Process

- The Fund is actively managed, with a wide investment remit. It exploits market inefficiencies through active allocation to a diverse range of market positions.

- By using a combination of diversified returns, the Fund seeks to minimise the impact of market volatility and therefore reduce risk. Risk, as measured by volatility, is not expected to exceed 5% in normal market conditions while maintaining the return objective.

### Derivatives and Techniques

- The Fund will make extensive use of derivatives to reduce risk, reduce cost and / or generate extra income or growth consistent with the risk profile of the fund. Derivatives can be used to generate growth, consistent with the Fund's risk profile, if market prices are expected to rise ('long positions') or fall ('short positions'). Leverage in the fund arises as a result of the use of derivatives. Examples of investment strategies implemented through derivatives are:

- An assessment of the direction of credit quality in one market compared to another.

- An assessment of the value of one currency relative to another.

- An assessment of the direction of interest rates.

### This fund is subject to Article 6 of the Sustainable Finance Disclosure Regulation ("SFDR").

Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus). If you invest in income shares, income from investments in the fund will be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares.

### Intended Retail Investor

Investors with basic investment knowledge. Investors wanting to preserve capital. Investors wanting a positive absolute return over the medium to longer term (3-5 years). The Fund has specific and generic risks with a risk rating as per the risk indicator. The Fund is intended for general sale to retail and professional investors through all distribution channels with or without professional advice.

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you sell it at an earlier stage. The value of investments and the income from them can go down as well as up, and you may get back less than you invested.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. - In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
