General Information

Structure

Kames Capital Investment Company (Ireland) Plc (the “Company”) is structured as an umbrella type open-ended investment company with variable capital consisting of a number of different sub-funds (“Funds”), incorporated on 25 June 2007 and is authorised in Ireland as an Undertaking for Collective Investment in Transferable Securities pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations, 2011 (the “UCITS Regulations”), supplemented or consolidated from time to time. Accordingly, the Company is supervised by the Central Bank of Ireland (the “Central Bank”).

Shares representing interests in different Funds may be issued from time to time by the Directors. Shares of more than one class may be issued in relation to a Fund. All shares of each class will rank *pari passu* save as provided for in the relevant Supplement. A separate portfolio of assets will be maintained for each Fund (and accordingly not for each class of shares) and will be invested in accordance with the investment objective and policies applicable to such Fund.

The Company has segregated liability between its Funds and accordingly any liability incurred on behalf of or attributable to any Fund shall be discharged solely out of the assets of that Fund.

The Company lists the majority of its share classes on the Irish Stock Exchange. All share classes that are listed on the Irish Stock Exchange can be found on ISE website (<http://ise.ie/>).

As at 31 October 2015, the Company has twelve Funds in existence however, only eleven of these Funds are open to new subscriptions: Kames Strategic Global Bond Fund, Kames Investment Grade Global Bond Fund, Kames High Yield Global Bond Fund, Kames Absolute Return Bond Fund, Kames Global Equity Income Fund, Kames Active Long Dated Bond Fund, Kames Equity Market Neutral Plus Fund, Kames Equity Market Neutral Fund, Kames Absolute Return Bond Global Fund, Kames Absolute Return Bond Constrained Fund and Kames Emerging Market Bond Fund. The Kames Global Opportunities Fund closed for subscription on 26 April 2013 and it is intended that applications will be made to the Central Bank to withdraw its approval by the end of the financial year.

The Board of Directors voluntarily complies with the Corporate Governance Code for Collective Investment Schemes and Management Companies as published by the Irish Funds Industry Association (the “IF Code”) in December 2011, as the Company’s corporate governance code. The Board of Directors has assessed the measures included in the IF Code as being consistent with its corporate governance practices and procedures for the period.

Investment Objectives and Policies of the Funds

Kames Strategic Global Bond Fund

The investment objective of the Kames Strategic Global Bond Fund is to maximise total return (income plus capital).

The Fund will seek to achieve its investment objective by investing at least two thirds of its net assets in global debt instruments in any currency, ranging from AAA government bonds through to high yield and emerging market bonds. The investment grade and government bond sector includes all fixed income securities available globally.

The Fund may invest in government and corporate bonds which may be at a fixed or floating rate, rated or unrated.

Kames Investment Grade Global Bond Fund

The investment objective of the Kames Investment Grade Global Bond Fund is to maximise total return (income plus capital).

The Fund will seek to achieve its investment objective by investing primarily in investment grade government and corporate bonds in any currency which may be at a fixed or floating rate, rated or unrated (deemed to have an equivalent rating by the Investment Manager). The Fund may also hold selected high yield bonds and cash.

Kames High Yield Global Bond Fund

The investment objective of the Kames High Yield Global Bond Fund is to maximise total return (income plus capital).

The Fund will seek to achieve its investment objective by investing at least two thirds of its net assets in high yield bonds (i.e. securities having a rating of Ba1 by Moody's or below or BB+ by Standard and Poor's or below, or other debt instruments deemed by the Investment Manager to be of similar credit quality) in any currency, which may be government or corporate, and which may be at a fixed or floating rate, rated or unrated. The Fund may also hold selected investment grade bonds and cash.

The Fund will invest primarily in high yield bonds whose credit rating is rated below investment grade.

Kames Global Opportunities Fund

The Kames Global Opportunities Fund is currently closed to new subscriptions and it is intended that applications will be made to the Central Bank to terminate the sub-fund.

On 26 April 2013, all shareholders fully redeemed from the Global Opportunities Fund on a compulsory basis. The anticipated costs of the liquidation and de-registration of the Global Opportunities Fund had been accounted for by the Fund prior to the shareholder redemptions.

Kames Absolute Return Bond Fund

The investment objective of the Kames Absolute Return Bond Fund is to generate positive total returns for investors over a rolling 3-5 year period irrespective of market conditions.

The Fund will seek to achieve its investment objective by investing in global debt instruments in any currency, ranging from AAA Government Bonds through to high yield and emerging market bonds. The Fund may invest in all types of fixed and floating rate fixed income securities.

Kames Global Equity Income Fund

The investment objective of the Kames Global Equity Income Fund is to provide income and capital growth over the longer term by investing in the global equities market. The Fund will aim to deliver a yield higher than that generally available from investment in global equities.

In seeking to achieve its investment objective the Fund intends to invest primarily in a portfolio of global equity securities providing an above average yield (i.e. a higher yield than the yield of the overall global equity market). The Fund may also invest to a limited extent in other securities and instruments.

Kames Active Long Dated Bond Fund

The investment objective of the Kames Active Long Dated Bond Fund is to maximise total return (income plus capital) whilst aiming to better manage exposure to interest rate and inflation risk.

The Fund will seek to achieve its investment objective by investing in a portfolio of government and corporate bonds, including index-linked bonds. The Financial Derivative Instrument ("FDI") will be utilised to tailor the Fund's interest rate, inflation and broad credit exposure to the Investment Manager's outlook for interest rates, inflation and broad credit risk.

The Fund will invest in a variety of global debt instruments in any currency, ranging from AAA government bonds through to sub-investment grade bonds which are also known as high yield bonds.

Kames Equity Market Neutral Plus Fund

The investment objective of the Kames Equity Market Neutral Plus Fund is to generate strong positive absolute returns for investors over a rolling 3 year period irrespective of market conditions.

The Fund will seek to achieve its investment objective by investing in companies based in the UK, principally conducting business in the UK or listed in the UK stock market. The Fund may also invest up to 10% in companies which are not UK companies. The Fund will invest in these companies or equity indices primarily using FDIs but may also invest directly in equities. The Fund may also invest to a limited extent in other securities and instruments.

Kames Equity Market Neutral Fund

The investment objective of the Kames Equity Market Neutral Fund is to generate positive absolute returns for investors over a rolling 3 year period irrespective of market conditions.

The Fund will seek to achieve its investment objective by investing in companies based in the UK, principally conducting business in the UK or listed in the UK stock market. The Fund may also invest up to 10% in companies which are not UK companies. The Fund will invest in these companies or equity indices primarily using FDIs but may also invest directly in equities. The Fund may also invest to a limited extent in other securities and instruments.

Kames Absolute Return Bond Global Fund

The investment objective of the Kames Absolute Return Bond Global Fund is to generate positive absolute returns for investors over a rolling 3 year period irrespective of market conditions with Sterling being the base currency of the Fund.

The Fund will seek to achieve its investment objective by investing in global debt instruments in any currency, ranging from AAA Government Bonds through to high yield and emerging market bonds. The Fund may invest in all types of fixed and floating rate fixed income securities and also in FDIs.

Kames Absolute Return Bond Constrained Fund

The investment objective of the Kames Absolute Return Bond Constrained Fund is to generate positive absolute returns for investors over a rolling 3 year period irrespective of market conditions with Euro being the base currency of the Fund.

The Fund will seek to achieve its investment objective by investing in global debt instruments in any currency, ranging from AAA Government Bonds through to high yield and emerging market bonds. The Fund may invest in all types of fixed and floating rate fixed income securities and also in FDIs.

It is expected that the Kames Absolute Return Bond Constrained Fund will have a slightly lower risk profile than the Kames Absolute Return Bond Global Fund.

Kames Emerging Market Bond Fund

The investment objective of the Kames Emerging Market Bond Fund is to maximise total return (income plus capital).

The Fund will seek to achieve its investment objective by investing at least 80% of its net assets in global debt instruments in various currencies, ranging from AAA Government bonds through to high yield and emerging market bonds. The Fund may invest in both sovereign and corporate emerging market bonds.

Directors' Report

The Directors present their annual report and audited financial statements for the financial year ended 31 October 2015.

Statement of Directors' Responsibilities in respect of the Financial Statements

The Directors are responsible for preparing the Annual Report and the financial statements in accordance with FRS 102 Financial Reporting Standard applicable in the UK and Republic of Ireland issued by the Financial Reporting Council (FRC) and promulgated by the Institute of Chartered Accountants in Ireland ("FRS 102") and the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations, 2011, as amended.

Irish company law requires the Directors to prepare financial statements for each financial period, which give a true and fair view of the state of assets, liabilities and financial position of Kames Capital Investment Company (Ireland) Plc (the "Company"), as at the end of the financial year, and of the profit or loss of the Company for that financial year. In preparing those financial statements, the Directors are required to:

- select suitable accounting policies and then apply them consistently;
- make judgments and estimates that are reasonable and prudent; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Company will continue in business.

The Directors are responsible for keeping adequate accounting records which disclose with reasonable accuracy at any time the financial position of the Company and which enable them to ensure that the financial statements comply with the provisions of the Companies Act 2014 and the European Communities (Undertaking for Collective Investment in Transferable Securities) Regulations, 2011 (the "UCITS Regulations"). They are also responsible for safeguarding the assets of the Company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Corporate Governance Code

General Principles

The European Communities (Directive 2006/46/EC) Regulation and Section 1373 of the Companies Act 2014 (the "Regulations") require the inclusion of a corporate governance statement in the Directors' Report.

The Company is subject to corporate governance practices imposed by:

- (i) The Irish Companies Act 2014 which are available for inspection at the registered office of the Company; and may also be obtained at <http://www.irishstatutebook.ie/home.html>
- (ii) The Articles of Association of the Company which are available for inspection at the registered office of the Company at 25/28 North Wall Quay, IFSC, Dublin 1 and at the Companies Registration Office in Ireland; and

Directors' Report (continued)

The Board of Directors is responsible for overseeing the operations of the Company. To assist the Board of Directors in the performance of its duties, the Company has appointed Clifton Fund Consulting Limited trading as KB Associates as a consultant which has seconded Cormac Byrne and Jamie Murphy on a part-time basis to the Company to carry out specific management functions assigned to them, as set out in the Company's Business Plan. Mr. Byrne and Mr. Murphy are located in Ireland.

The Board of Directors voluntarily complies with the Corporate Governance Code for Collective Investment Schemes and Management Companies as published by the Irish Funds Industry Association (the "IF Code") in December 2011, as the Company's corporate governance code and which can be obtained at: <http://www.irishfunds.ie/regulatory-technical/corporate-governance>. The Board of Directors has assessed the measures included in the IF Code as being consistent with its corporate governance practices and procedures for the financial year.

Internal Control and Risk Management Systems in Relation to Financial Reporting

The Board of Directors is responsible for establishing and maintaining adequate internal control and risk management systems of the Company in relation to the financial reporting process. Such systems are designed to manage rather than eliminate the risk of error or fraud in achieving the Company's financial reporting objectives and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board of Directors has procedures in place to ensure all relevant accounting records are properly maintained and are readily available, including production of annual and half-yearly financial statements. The annual and half-yearly financial statements of the Company are required to be approved by the Board of Directors of the Company, the annual and half-yearly financial statements of the Company are required to be filed with the Central Bank and the annual financial statements of the Company are required to be filed with the ISE. The annual statutory financial statements are required to be audited by independent auditors who report annually to the Board of Directors on their findings.

The Board of Directors evaluates and discusses significant accounting and reporting issues as the need arises. The Board of Directors has appointed Citibank Europe Plc as its Administrator. The Administrator maintains the books and records of the Company. The Administrator is authorised and regulated by the Central Bank and must comply with the rules imposed by the Central Bank. From time to time the Board of Directors also examines and evaluates the Administrator's financial accounting and reporting routines and monitors and evaluates the external auditors' performance, qualifications and independence.

Dealings with Shareholders

The convening and conduct of shareholders' meetings are governed by the Articles of Association of the Company and the Companies Acts. Although the Directors may convene an extraordinary general meeting of the Company at any time, the Directors are required to convene an annual general meeting of the Company within fifteen months of the date of the previous annual general meeting. Shareholders representing not less than one tenth of the paid up share capital of the Company may also request the Directors to convene a shareholders' meeting. Not less than twenty one days' notice of every annual general meeting and any extraordinary general meeting convened for the passing of a special resolution must be given to shareholders and fourteen days' notice must be given in the case of any other extraordinary general meeting unless the auditors of the Company and all the shareholders of the Company entitled to attend and vote agree to shorter notice.

Two members present either in person or by proxy constitute a quorum at a general meeting provided that the quorum for a general meeting convened to consider any alteration to the class rights of shares is two shareholders holding or representing by proxy at least one third of the issued shares of the relevant Fund or class.

Every holder of participating shares present in person or by proxy who votes on a show of hands is entitled to one vote and the holder(s) of subscriber shares present in person or by proxy shall have one vote in respect of all the subscriber shares in issue. On a poll, every holder of participating shares present in person or by proxy is entitled to one vote in respect of each share held by him and every holder of a subscriber share present in person or by proxy is entitled to one vote in respect of his holding of subscriber shares.

Shareholders may resolve to sanction an ordinary resolution or special resolution at a shareholders' meeting. An ordinary resolution of the Company or the shareholders of a particular Fund requires a simple majority of the votes cast by the shareholders voting in person or by proxy at the meeting at which the resolution is proposed. A special resolution of the Company requires a majority of not less than 75% of the shareholders present in person or by proxy and voting in general meeting in order to pass a special resolution including a resolution to amend the Articles of Association.

Board composition and activities

Unless otherwise determined by an ordinary resolution of the Company in the general meeting, the number of Directors may not be less than three. Currently the Board of Directors of the Company is composed of three Directors, being those listed in the Directory in these financial statements.

The business of the Company is managed by the Directors, who exercise all such powers of the Company as are not by the Companies Acts or by the Articles of Association of the Company required to be exercised by the Company in general meeting.

A Director may, and the company secretary of the Company on the requisition of a Director will, at any time summon a meeting of the Directors. Questions arising at any meeting of the Directors are determined by a majority of votes. In the case of an equality of votes, the chairman has a second or casting vote. The quorum necessary for the transaction of business at a meeting of the Directors is two.

There are no sub-committees of the Board of Directors.

Review of the Development of the Business and Future Developments

The Directors have entrusted the management of the Funds to the Investment Manager. The investment management activities, the details of the development of the Funds over the last financial year and the future plans for the Funds are reviewed in detail in the Investment Manager's Report on pages 12 to 22.

Risk management objectives and policies

The Company has been approved by the Central Bank as an Undertakings for Collective Investments in Transferable Securities ("UCITS") Fund. It is an umbrella Fund which at the date of this report consisted of twelve Funds. Eleven Funds were operational during the period under review. One of the Funds, the Global Opportunities Fund closed for subscriptions on 26 April 2013.

A detailed review of the principal risks and the management of those risks are included in Note 12 on pages 64 to 136.

Investment Manager's Report

Kames Strategic Global Bond Fund

The Kames Strategic Global Bond Fund returned 0.13% over the 12-month period, compared to the peer group median return of 0.26%. The peer group is the Lipper Global Bond Global sector.

Throughout the period, the Fund retained a conservative approach, which was mainly manifested in our low duration beta strategy. In particular we tended to run with a short position in interest rate risk, given our view that many rates markets were overvalued. To balance our lack of appetite for beta we sought to utilise the multitude of ways available to the Fund to generate alpha in rates markets. This involved identifying where to take interest-rate exposure both by geography and the Fund's curve positioning. Therefore, while we retained our strategic short stance, we did take short-term tactical positions as warranted by the prevailing conditions. This allowed us to add some value without adding materially to the overall level of risk in the Fund. We benefited for example, from taking a position in Swedish government bonds prior to the Central Bank announcing an interest rate cut. During the first half 2015 we also profited from a small position in Spain, having taken profits in our Swedish exposure.

In terms of curve positioning, we add value by exploiting yield curve flattening movements. In particular, we recognised there was an opportunity to profit from a flattening of the US yield curve between the 5-year and 30-year areas. This positioning, while volatile at times, contributed positively overall and was particularly beneficial in the first half of the period.

Within the investment grade sector we held a preference for bonds issued by financial institutions including banks and insurance companies, although we reduced the size of our exposure to banks as the period progressed. We tended to invest down the capital structure in the strong survivors rather than taking 'bail-in' risk in those banks on sovereign life-support. We also retained our bias towards the collateralised sector (bonds secured against underlying assets).

Overall our exposure to investment grade bonds produced mixed results in performance terms. During the summer of 2015 volatility levels increased markedly; a combination of concerns about global economic weakness and idiosyncratic company risk caused riskier assets including corporate bonds to falter. We had very little exposure to the worst affected companies but the wider effects on large sectors such as automobiles, and pharmaceuticals ensured that the market as a whole came under some pressure.

The high yield sector was also volatile over the period with bonds issued by energy companies suffering as the price of commodities continued to fall. We had selectively invested in good quality energy companies following the sharp decline in the oil price during the second half of 2014, and subsequently took profits in these positions as the oil price stabilised in early 2015. However the oil price began to fall again over the remainder of the period and we therefore managed our exposure carefully to shield the Fund from the worst of the turbulence.

Kames Investment Grade Global Bond Fund

The Kames Investment Grade Global Bond Fund returned 2.46% compared to 1.30% for the Barclays Global Aggregate Corporate index.

Fixed income assets performed well over the 12 months under review, buoyed by accommodative central bank policies, particularly in the eurozone and Japan, and a benign inflationary backdrop. It was, however, a volatile period with uncertainty about when the US Federal Reserve would begin to raise rates causing concern.

We began the period fully invested - with a full weighting to credit - and took advantage of a very strong new issue pipeline to add value to the Fund. We retained our preference for the US dollar market, where we favoured the more attractive valuations and diversity. During the first half of the period however, we also invested selectively in the euro new issue market as we sought to benefit from the ever more aggressive grab for yield in euro-denominated credit against a backdrop of near-zero rates. This general positioning benefited Fund performance, with stock selection also aiding relative returns.

The second quarter of 2015 saw renewed concerns around Greece emerge, with risk appetite further negatively impacted by fears over the sustainability of Chinese growth as we entered the summer months. Growing uncertainty over the intentions of the US Federal Reserve also contributed to the volatility. Correspondingly, we sought to increase the cash weighting in the Fund, in an effort to protect the portfolio from the heightened risk aversion that was permeating markets. We reduced some of the Fund's euro assets in July and August (which had held up well on a relative basis) and increased the Fund's cash balance. The conviction around positioning the portfolio defensively was strengthened by the dearth of attractive opportunities available through much of the second and third quarters of 2015. New issuance was generally markedly less attractive in the wake of the ECB's quantitative easing programme, with deals typically upsized and pricing tightened too aggressively pre-launch. Towards the period-end we deployed some of the cash to invest in selected new issuance that was priced with significant concessions to the secondary market. Our cautious positioning during the second half of the period helped to shield the Fund from much of the volatility, and to outperform over the year as a whole.

In terms of interest rate risk, we did not take any significant relative positions, but instead added value from a number of small active positions that sought to profit from the prevailing market conditions. At the start of the period we reduced the size of our short duration stance and maintained a close to neutral position relative to index as we entered 2015. As volatility picked up (around the second quarter of 2015) we benefited from taking a series of small positions that took advantage of the uncertainty created by central banks' policy comments and events in the eurozone, where the latest instalment of the Greek debt crisis was developing. We retained a relatively neutral duration position as we approached the end of the period, with little appetite to oppose the expensive valuations given the heightened risk aversion which permeated markets.

Kames High Yield Global Fund

The Kames High Yield Global Bond Fund returned 0.73% over the 12-month period, compared to -0.58% for the peer group median. The peer group is the Lipper Global Bond Global High Yield sector.

During the 12 months under review we retained the Fund's focus on disciplined issue selection, particularly through the new issue pipeline, as a means of adding value to the Fund. We believe that our positioning was relatively conservative versus peers, particularly in respect of the energy sector.

In regional terms, we continued to favour the larger, more established US high yield market over a European market dominated by debut issuers, as we believed the former offered a better risk/reward balance. In addition, a small proportion of the Fund was invested in sterling denominated assets, with the remainder invested in a number of Swiss franc, Canadian dollar and Swedish krona denominated bonds, among others. All of the Fund's holdings were hedged back to the base currency (US dollar).

Our geographic positioning had mixed results over the period and the Fund typically performed better when the US high yield market outperformed the European market. Our reluctance to add some riskier European assets after a weak third quarter in 2014 detracted from performance at times when these assets rallied, but we believed that buying weak credits on the basis of a potentially transient market technical would not be wise.

Our favoured area for investing was generally in 5 to 7-year B-rated debt due to its economic sensitivity and fair value. When possible we focused on the new issue market as a means of identifying good opportunities although we remained highly selective when participating in new issuance, particularly from debut companies. Where we did not see opportunities in the primary market, we preferred to add to existing quality names rather than add lower quality bonds, where investors are not being adequately compensated for the higher risks.

Within sector positioning we maintained our preference for less cyclical sectors such as TMT, consumer non cyclicals and healthcare. Moreover, we added value by careful positioning within the energy sector. At the start of the period, this area of the market came under severe pressure as the oil price collapsed; the Fund was not immune to the sell-off but had a significant quality bias – both by rating and towards the more defensive midstream companies. This helped to limit any absolute drawdown and support relative performance.

The energy sector continued to be turbulent as we moved into 2015. Having added a moderate amount of risk in Dec 2014, we took some profits in April as we anticipated some give-back of what had been a very strong rally in the first quarter. In the event the correction was much more severe than we or the market anticipated as some demand concerns added to a stretched supply scenario. Therefore the sector has underperformed our expectations and has detracted from performance albeit we believe that our positioning remained conservative versus many peers.

Credits that were solid contributors to overall performance included Service Corporation (a US death care provider), Heathrow Airport, Thomas Cook (holiday company actively targeting an improved credit profile), Burger King and Virgin Media.

Kames Absolute Return Bond Fund

Over one year to 31 October 2015, the Kames Absolute Return Bond Fund has returned 0.61% compared to the LIBOR GBP 3-month benchmark return of 0.57%.

The Fund's Carry module (investing in a range of short-dated investment grade bonds) and Credit module (focusing on credit-neutral relative value positions within global investment grade, high yield and emerging markets) both contributed positively to the outperformance against the benchmark. The Rates module (focusing primarily on duration-neutral relative-value positions) was slightly negative.

Over the period, both government and corporate bonds performed well although, as in previous years, investors had to contend with a significant amount of volatility. Once again, central banks were at the centre of the turbulence; their actions (both real and anticipated) continued to generate uncertainty regarding the future direction of monetary policy.

Within the Credit module, a number of our single name pair trades added value. These included a long Ardagh versus short Stena via a CDS (credit default swap) position. Stena had seen its fundamentals deteriorate since the summer of 2014 and we did not think this was reflected in its CDS price. After some further bad news for the company, we closed the position at a profit in January. Our long MGM versus short Ladbrokes position also performed well after the latter issued disappointing results in February. We subsequently closed the position profitably at the end of the period. Elsewhere our long position in 5-year iTraxx Senior Financials against a short in non-financial corporates via 5-year iTraxx Main was a strong performer, as was a long Brazil versus short Columbia position using single-name CDS.

Later in the year, the sharp decline in prices across the commodity complex caused the underperformance of most energy and commodity bonds, including Glencore and Anglo American. We opened a long-risk Glencore and Anglo American against short-risk iTraxx Crossover early in the third quarter of 2015 to benefit from any rebound in commodity performance. Unfortunately, the weakness in commodity prices continued and pushed the trade against us. A disappointing set of quarterly results further added to Glencore's troubles. We did offset some of this loss by switching the short leg from iTraxx crossover to Anglo-American, focusing the trade on the relative valuation between these two commodity companies. In response to ongoing pressure, Glencore announced a package of measures, including the raising of additional equity, to help improve its credit position. This had a large and immediate impact, giving us the opportunity to close this second trade at a profit, and to recover some of the lost performance from the first trade.

Also of concern to the Fund's performance was the news about Volkswagen towards the end of the quarter. We are long Volkswagen against a combination of Volvo and Daimler via 5-year credit default swaps (CDS), and the announcement of Volkswagen's 'rigging' of its emissions testing caused the value of its debt and equity to crater. Even our low exposure of 2% detracted from the Fund's performance. However, with the CDS spread pricing in multiple downgrades, we opted to retain our position; if the scale of the downside or uncertainty grows, we may then have to reassess.

Returns from the Rates module were mixed although it posted a slight negative return for the period as a whole. During the first half of 2015, we held a long position in 10-year Australian bond futures, initially against 10-year US bond futures and then latterly against a short in 10-year UK bond futures. This position worked against the Fund as the Reserve Bank of Australia surprised the market by not cutting interest rates early in April, while its decision to implement a rate cut in early May was accompanied by a comment that rates would stay on hold for the foreseeable future.

We also held a long 10-year Spain versus short 10-year Italy position throughout the summer period, on the belief that Spain was a stronger credit than Italy, and that Spanish government bonds (SPGBs) were therefore cheap compared with Italian government bonds (BTPs). Unfortunately, towards the end of this period, the market focused on Spanish political risk, and when domestic investors reduced their appetite for SPGBs, the spread versus BTPs continued to lurch wider. Our formal review favoured closing the position at a small loss to performance.

The Carry module continued to perform in line with expectations. Its diversified range of high quality, short dated assets delivered a positive return with little volatility, highlighting the importance of the module to the overall stability of the Fund.

Kames Global Equity Income Fund

The Kames Global Equity Income Fund returned 4.57% over the 12-month period, compared to -1.18% for the peer group sector median return. The peer group is the Lipper Global Equity Global Income sector.

Investors had much to contemplate over the period with volatility continuously affecting the global equity market. The European Central bank started its quantitative easing programme in March, which had the effect of dramatically lowering the value of the euro in foreign exchange markets. January saw the Swiss monetary authorities abandon the franc's peg to the single currency, while no fewer than 33 central banks, from Azerbaijan to Ukraine, cut interest rates. Greece became the first ever developed country to default on a loan from the IMF, and sterling enjoyed strong support from an unexpectedly decisive result in the UK's May general election. China's stock market boomed then collapsed, and the People's Bank of China announced a shock devaluation of its currency in August. This deliberate policy measure was a direct reaction to weakening domestic economic activity and fears mounted of the potential for a regional currency war. While the action was widely interpreted as a bid to boost the competitiveness of China's exports on the back of the softening of the Japanese yen and the Korean won especially over the past year, it has implications for China's ambition to internationalise its currency, and risks triggering material capital outflows.

Regional/currency allocation was a consistent headwind to performance, due mainly to the Fund's underweight positions in Japan - where the market outperformed on optimism that policy and reform measures were having the desired effect of boosting shareholder rights and economic activity – and in the US – which continued to win in common currency terms largely on account of the strength of the dollar. Some offset was provided by our very light exposures to emerging markets. Stock selection however was excellent with strong results in all areas with the exception of Japan, and particularly outstanding results were delivered in both Europe and North America. Many of the best-performing stocks benefited from a market preference for typically defensive characteristics, such as household products specialist Clorox, domestic financial services providers Moneysupermarket.com and Direct Line, and tobacco manufacturer Reynolds American, which attracted marked support for its merger with domestic competitor Lorillard. Low-cost carrier Ryanair was another standout performer thanks to regular profitability upgrades throughout the period on persistent market share gains. Sector allocation was also a positive contributor to portfolio performance, driven by a significant underweight to the commodity price-sensitive sectors, particularly oil and gas and mining, and overweight positions in both consumer staples and financials, especially insurance.

On the downside data storage outfit Seagate Technology struggled to meet its earnings outlook but softened the blow with a decent increase in quarterly distributions, and in banks, Australia's ANZ Banking Group lagged on both a decision to raise regulatory capital and currency weakness. Sands China was the other notable detractor as results at the Hong Kong-listed casino and hotel operator were adversely affected by China's economic downturn and a crackdown on corruption in the gambling industry.

Kames Active Long Dated Fund

The Kames Active Long Dated Bond Fund returned 3.72% over the 12-month period compared to 5.38% for the composite benchmark index. The benchmark is a composite of 2/3 iBoxx Sterling Non-Gilts > 10-yr index and 1/3 FTSE Index Linked All Stock index.

Fixed income assets performed well over the 12-month period, with government, corporate and index-linked bonds all rallying. It was, however, a volatile period; geopolitical crises, the latest instalment of the Greek debt crisis and concerns about the future direction of European Central Bank monetary policy, all conspired to ensure the backdrop remained turbulent.

For the majority of the period the Fund retained a short duration position, given our view that gilt yields were too low and offered little value. We also tended to hold an underweight exposure to index-linked bonds. In both cases, however, we actively managed the size of our positions to cater for the prevailing market conditions. Within credit, we continued to favour bonds issued by financial institutions over non-financials such as industrials, telecoms and utilities. We also retained our long-held preference for the collateralised sector (bonds secured against an underlying asset).

Overall, this positioning benefited the Fund but the poor performance of the inflation swap, which was in place throughout the 12 months, resulted in an underperformance against the benchmark index.

While our short duration position came under pressure, given the strength seen in government bonds, we did add value at various points during the period by implementing short-term tactical trades. For example, in August 2015 we ran an overweight position in 30-year long gilts against a short in 10-year gilts. As the curve began to flatten in the middle of the month, we closed the position at a profit. We also profited from trading around major supply events, particularly in the index-linked sector; our underweight in the 50-year area versus shorter-dated maturities and the benchmark worked well into the middle of September as an upcoming supply event (a 2068 index-linked bond) began to weigh on the market.

Within credit, our preference for the financial sector added value. Within the banks sector, our holdings in longer-date bonds from HSBC, Credit Suisse and Citigroup were among the best performers. In the other financial sector, our exposure to Wheatley Group, which was a new bond issued during the period, worked well. Within the collateralised sector, Dignity Finance (funeral services operator) was the standout name. During the first six months of the period the company conducted a re-financing programme in which the bonds were exchanged. While we limited our exposure to non-financial bonds, some of the names we did invest in performed well. For example, our exposure to 100-year bonds issued by utility company EDF performed very well, with long-dated credit helped by the rally seen in gilts.

Kames Equity Market Neutral Plus Fund

The Kames Equity Market Neutral Plus Fund returned -0.37% compared to the LIBOR GBP 1 Month return of 0.46%. (Note: the Fund was launched on 2 December 2014)

(Gross of management fees, the Fund returned 0.78%, outperforming the benchmark by 31 basis points.)

Developed economies such as the UK and US continued to make some (albeit erratic) progress and this led investors to speculate about when interest rates would rise from their record low levels. However, events elsewhere in the global economy conspired to ensure that rates were left on hold and equity markets came under pressure, particularly in the second half of the period. The main cause of concern was the sharp slowdown in the Chinese, as well as other emerging market, economies. As a result, commodity prices fell sharply over the period and added to concern over the lack of growth in the global economy. The oil price, having fallen sharply in the fourth quarter of 2014, continued to ensure a significant amount of volatility over the period. Our Pair Trades module made a positive contribution to performance over the period. Pair trades in the mining sector added value in the first six months but were less successful towards the end of the period as the market favoured quality in a weakening commodity environment. Our utilities pair benefited from a long position re-rating on the conclusion of a regulatory review in December. Our pairing within the sector was again beneficial in June where our long position was subject to bid speculation. Elsewhere, pairs in property and transport also provided more modest contributions to the performance of the module.

We continue to run the Fund with a balanced approach, keeping the risk profile well within our tolerance range and market beta (a measure of how closely the Fund moves with the market) close to zero.

The Volkswagen emissions testing scandal broke in September, engulfing the auto industry and negatively impacting our long positions in auto catalyst manufacturer Johnson Matthey and engineering services company Bodycote. Meanwhile, falling diamond prices negatively affected our position in Petra Diamonds.

Our Pair Trades module made a positive contribution to performance over the period. Pair trades in the mining sector added value in the first six months but were less successful towards the end of the period as the market favoured quality in a weakening commodity environment. Our utilities pair benefited from a long position re-rating on the conclusion of a regulatory review in December. Our pairing within the sector was again beneficial in June where our long position was subject to bid speculation. Elsewhere, pairs in property and transport also provided more modest contributions to the performance of the module.

We continue to run the Fund with a balanced approach, keeping the risk profile well within our tolerance range and market beta (a measure of how closely the Fund moves with the market) close to zero.

Kames Absolute Return Bond Global Fund

The Kames Absolute Return Bond Global Fund was launched on 29 April 2015.

The Fund's objective is to generate positive absolute returns for investors over a rolling 3-year period irrespective of market conditions (LIBOR GBP 3 months +2.5% per annum over a rolling 36-month period). The Fund shares many similarities with the existing Kames Absolute Return Bond Fund, while using a broader investment universe that offers a wider opportunity-set and greater capacity.

The Fund uses three 'modules' to generate performance – credit & asset allocation, rates and carry. The modules are not standalone portfolios, but are different components of the Fund based on how they invest in the market. In the credit & asset allocation module we aim to add value from high conviction credit and fixed income asset class views. We harness top-down and bottom-up outputs from existing team strategies, coverings areas such as credit stock selection, fixed income asset class, sector, region and credit curve relative value. In the rates module, we focus on duration-neutral relative value positions using, for example, cross market, yield curve and inflation breakeven strategies. In the carry module we generate income from a portfolio of global investment grade bonds.

Kames Absolute Return Bond Constrained Fund

The Kames Absolute Return Bond Constrained Fund was launched on 29 April 2015.

The investment objective of the Fund is to generate positive absolute returns (1% per annum above the 1-month EURIBOR rate, net of fees) for investors over a rolling 3 year period irrespective of market conditions.

The Fund uses three investment modules to generate performance. The modules are not standalone portfolios, but are different components of the fund based on how they invest in the market. The Carry module invests globally in short-dated, high quality corporate bonds, with the aim to generate income, or 'carry'. In the Rates module we aim to add value from duration-neutral relative value positions from global government bond markets. Our main strategies are cross-market pair trades, yield curve positions and inflation breakeven trades. In the Credit module we aim to generate small amounts of performance from traditional stock selection from our credit team's highest conviction ideas.

A full review will follow in the interim report to 30 April 2016.

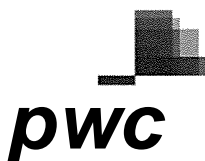

Notes to the Financial Statements

1. Significant Accounting Policies

a) Statement of Compliance

The financial statements are prepared in accordance with FRS 102 Financial Reporting Standard applicable in the UK and Republic of Ireland issued by the Financial Reporting Council (FRC) and promulgated by the Institute of Chartered Accountants in Ireland ("FRS 102") and the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations, 2011, as amended. FRS 102 is mandatory for accounting periods beginning on or after 1 January 2015. The Board of Directors have taken the option to apply the standard early in the preparation of these financial statements. The financial statements have been prepared on a historical cost basis, except for financial instruments classified at fair value through profit or loss that have been measured at fair value.

The format and certain wordings of the financial statements have been adapted from those contained in the FRS 102 and the Companies Act 2014 so that, in the opinion of the Directors, they more appropriately reflect the nature of the Company's business as an investment fund.

b) Basis of Accounting and Presentation of Financial Statements

The financial statements are measured and presented in the currency of the primary economic environment in which each Fund operates. These are the United States Dollar ("USD"), Euro ("EUR") and Pound Sterling ("GBP") reflecting the fact that the Funds' operations are conducted in USD, EUR and GBP.

The financial statements are prepared on a fair value basis for the financial assets and financial liabilities through profit and loss. The financial statements have been prepared on the going concern basis for all Funds except for Kames Global Opportunities Fund which closed for subscriptions on 26 April 2013.

As approved by the Board of Directors, the financial statements for the year ended 31 October 2015 are based on the valuation prepared at close of business on 30 October 2015 and not the official midday GMT valuation which was used to prepare the financial statements up to 31 October 2014. This new approach will be applied going forward and is in line with accounting standards.

First-time adoption of FRS 102

The Company has adopted FRS 102 for the financial year ended 31 October 2015. In the prior financial year, the financial statements were prepared in accordance with Accounting Standards issued by the FRC and promulgated by the Institute of Chartered Accountants in Ireland ("Generally Accepted Accounting Practice in Ireland"). Accordingly, the Company has restated the comparative prior financial year amounts in the primary statements to comply with FRS 102.

The Board of Directors have considered how the transition from Irish GAAP to FRS 102 has affected the Company's reported financial position and financial performance. There has been no impact on the valuation or classification of these amounts as a result of the transition to FRS 102. The Company has also availed of the exemption available under FRS 102 not to prepare a statement of cash flows.

Fair value measurement

On initial application of FRS 102, in accounting for its financial instruments a reporting entity is required to apply either a) the full requirements of FRS 102 relating to Basic Financial Instruments and Other Financial Instruments, b) the recognition and measurement provisions of IAS 39 Financial Instruments: Recognition and only the disclosure requirements of FRS 102 relating to Basic Financial Instruments and Other Financial Instruments, or c) the recognition and measurement provisions of IFRS 9 Financial Instruments and only the disclosure requirements of FRS 102 relating to Basic Financial Instruments and Other Financial Instruments. The Company has chosen to apply the full requirements of FRS 102 relating to Basic Financial Instruments and Other Financial Instruments.

Fair value disclosures

The requirement for the Company to measure financial instruments at fair value and the estimation of that fair value has not changed with the adoption of FRS 102. However the levels in the fair value hierarchy into which the fair value measurements are categorised for disclosure purposes have changed from that previously disclosed by the Company. See Note 12 in the notes to the financial statements for further details.

b) Basis of Accounting and Presentation of Financial Statements (continued)

The preparation of financial statements requires management to make judgments, estimates and assumptions that affect the application of policies and reported accounting policies and the reported amounts of assets and liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable. The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period or in the periods of revision and future periods if the revision affects both current and future periods. Actual results could differ from estimates.

Prior year balances of shareclass hedging fee, transfer agency fee and swap expense have been reclassified for consistency with the current year disclosure. Prior year reconciliation between dealing NAV and reporting NAV and cash and cash equivalents breakdown have also been disclosed on the face of Statement of Financial Position for consistency with the current year disclosure.

On 2 December 2014 the Kames Equity Market Neutral Fund and the Kames Equity Market Neutral Plus Fund were launched. On 29 April 2015 the Kames Absolute Return Bond Global Fund and the Kames Absolute Return Bond Constrained Fund were launched. On 29 October 2015 Kames Emerging Market Bond Fund was launched. There are no comparative figures included for these Funds as their prior year balances are not available.

c) Foreign Currency Translation

While the Funds' operations are conducted in USD, EUR and GBP, the functional currency of the Company is USD, (as the Directors have determined that this reflects the Company's primary economic currency). The presentation currency of the Company is also USD. Transactions in foreign currencies are translated at the foreign currency exchange rate ruling at the date of the transaction. Monetary assets and liabilities denominated in foreign currencies are translated to USD at the foreign currency exchange rate ruling at the Statement of Financial Position date. Foreign currency exchange differences arising on translation and realised gains and losses on disposals or settlements of monetary assets and liabilities are recognised in the Statement of Comprehensive Income. Foreign exchange gains/losses relating to investments at fair value through profit or loss are included in gains and losses on investments in the Statement of Comprehensive Income.

The Statement of Financial Position is translated using exchange rates at the financial year end and the Statement of Comprehensive Income and Statement of Changes in Net Assets Attributable to Redeemable Participating Shareholders are translated at an average rate over the financial year for inclusion in the combined financial statements of the Company. The resulting notional currency gain/(loss) and the notional currency gain/(loss) on retranslation of opening net assets is included in the Statement of Changes in Net Assets Attributable to Redeemable Participating Shareholders. The method of translation has no effect on the value of net assets allocated to the individual Funds.

d) Financial Instruments

(i) Classification

The Company designates all its investments into financial assets and liabilities at fair value through profit or loss in accordance with FRS 102. The category of financial assets and liabilities at fair value through profit or loss comprises:

Financial instruments held for trading: These include all financial instruments, (as the Company does not designate any derivatives as financial hedges) including futures, options, swaps, forward contracts, bonds and equities.

Financial instruments designated at fair value through profit or loss upon initial recognition: These include financial assets that are not held for trading purposes and which may be sold.

These financial instruments are designated on the basis that their fair value can be reliably measured and their performance has been evaluated on a fair value basis in accordance with the risk management and/or investment strategy as set out in the Company's offering document.

(ii) Classification (continued)

Gains and losses arising from changes in the fair value of the financial assets and liabilities at fair value through profit or loss category are included in the Statement of Comprehensive Income in the financial year in which they arise.

(iii) Recognition and Derecognition

All regular way purchases and sales of financial instruments are recognised on the trade date, which is the date that the Company commits to purchase or sell an asset. Regular way purchases or sales are purchases or sales of financial instruments that require delivery of assets within the period generally established by regulation or convention in the market place. Realised gains and losses on disposals of financial instruments, with the exception of futures and options, are calculated using the average cost method. Realised gains and losses on disposals of futures and options are calculated using the First In First Out (FIFO) method.

The Company derecognises a financial asset when the contractual rights to the cash flows from the financial asset expire or a financial asset is transferred and the transfer qualifies for derecognition in accordance with FRS 102.

The Company derecognises a financial liability when the obligation specified in the contract is discharged, cancelled or expires.

(iv) Measurement

Financial instruments are measured initially at fair value (transaction price). Transaction costs on financial assets and financial liabilities at fair value through profit or loss are expensed immediately.

Subsequent to initial recognition, all instruments classified at fair value through profit or loss are measured at fair value with changes in fair value recognised in the Statement of Comprehensive Income.

Financial liabilities arising from redeemable shares issued by the Company are carried at redemption amount representing the investors' right to a residual interest in the Company's assets.

(iv) Fair value measurement principles

Fair value is the amount for which an asset could be exchanged, or a liability settled, between knowledgeable, willing parties in an arm's length transaction.

The fair value of financial instruments is based on their quoted market prices on a recognised exchange or sourced from reputable brokers/counterparties or independent market data providers, in the case of non-exchange traded instruments, at the Statement of Financial Position date without any deduction for estimated future selling costs. Financial assets are priced at their current bid prices, while financial liabilities are priced at their current offer prices.

For all other financial instruments not traded in an active market or where no broker/counterparty quotes can be obtained, the fair value is determined by using appropriate valuation techniques, which include using arm's length transactions; reference to the current market value of another instrument that is substantially the same; discounted cash flow analysis and option pricing models making as much use of available and supportable market data as possible.

Subsequent changes in the fair value of financial assets and liabilities at fair value through profit or loss are recognised in the Statement of Comprehensive Income.

The investments have been valued at bid market prices for long positions and ask market prices for short positions at 12 noon GMT on 30 October 2015.

e) Cash, Cash Equivalents, Bank Overdrafts and Collateral

Cash and cash equivalents include cash in hand, deposits held at call with banks and other short-term investments in an active market with original maturities of three months or less and bank overdrafts. Bank overdrafts are shown in Current Liabilities in the Statement of Financial Position.

e) Cash, Cash Equivalents, Bank Overdrafts and Collateral (continued)

Short-term investments that are not held for the purpose of meeting short-term cash commitments are not considered as 'cash and cash equivalents'.

Broker cash received as collateral is recorded as an asset on the Statement of Financial Position 'Collateral receivable from broker' and a related liability to repay the collateral is disclosed within Current Liabilities as 'Collateral payable to broker'. The cash received from broker as collateral is not invested to purchase other investments in the relevant Funds.

Cash collateral provided by the Funds to a counterparty in relation to futures contracts are identified in the Statement of Financial Position as 'Margin at broker'. Cash pledged as collateral for financial derivative instrument transactions is not included as a component of cash and cash equivalents in the Statement of Financial Position and is not available to the Funds on demand. Margin at broker/Collateral cash is valued at amortised cost plus accrued interest which approximates fair value.

Collateral pledged to counterparties other than cash is disclosed in the Statement of Financial Position as financial assets at fair value through profit or loss pledged as collateral. As at 31 October 2015 and 31 October 2014, there was no collateral held by the Funds other than cash.

f) Operating Expenses

Operating expenses of the Company are expensed in the period to which they relate.

g) Interest and Dividend Income

Interest income is recognised in the Statement of Comprehensive Income as it accrues. Bond interest is recognised as income on an effective yield basis using the original effective interest rate of the instrument calculated at the acquisition or origination date. Bond Interest income includes amortisation of any discount or premium, transaction costs or other differences between the initial carrying amount of an interest-bearing instrument and its amount at maturity calculated on an effective interest rate basis. Dividends are recognised in the Statement of Comprehensive Income on the dates on which the relevant securities are listed as "ex-dividend". Withholding tax is presented gross in the Statement of Comprehensive Income.

h) Swap Income and Expense

In 2012, the Company implemented a policy which splits gains or losses on Swaps into income or expense and capital for the purpose of calculating a more accurate distribution on the Funds. These amounts are shown in the Statement of Comprehensive Income on pages 27 to 32.

i) Net Asset Value Per Share

The Net Asset Value per share for each Fund is calculated by dividing the total Net Asset Value of each Fund by the total number of shares outstanding for that Fund.

j) Distributions

Distributions to holders of Redeemable Participating Shares are recorded in the Statement of Comprehensive Income as finance costs.

k) Redeemable Participating Shares

All Redeemable Participating Shares issued by the Funds provide the investors with the right to require redemption for cash at the value proportionate to the investor's share in the Funds' net assets at the redemption date. In accordance with FRS 102 such instruments give rise to a financial liability for the present value of the redemption amount. The redemption price for each redeemable share is equal to the Net Asset Value per redeemable shares on the dealing day. The Net Asset Value per redeemable share is determined as at 12 noon GMT on each valuation day in accordance with the provisions set out in the Prospectus. Financial assets at fair value through profit or loss are reflected at bid-market prices. The Net Asset Value per share class in each Fund is outlined on the Statement of Financial Position.

l) Dilution Adjustment

A Fund may suffer dilution which is a reduction in the value of the assets as a result of the costs incurred in dealing in its underlying investments and of any spread between the buying and the selling prices of such investments which is not reflected in the issue or redemption price paid by or to shareholders. With a view to countering this (which, if it is significant, disadvantages existing or continuing shareholders), the Directors may make an adjustment to the share price on a daily and quarterly basis.

The dilution adjustment may apply to redemptions or to subscriptions and if charged, the value of the dilution adjustment will be paid into the Fund and will become part of the property attributed to the relevant Fund.

Dilution adjustments are disclosed in Statement of Changes in the Net Assets Attributable to Redeemable Participating Shareholders on page 39 to 41.

m) Transaction Costs

Transaction costs are defined as the incremental costs that are directly attributable to the acquisition, issue or disposal of a financial asset or financial liability. An incremental cost is one that would not have been incurred if the entity had not acquired, issued or disposed of the financial instrument. When a financial asset or financial liability is recognised initially, an entity shall measure it at its fair value through profit or loss.

Transaction costs on the purchase and sale of bonds, forwards and swaps are included in the purchase and sale price of the investment. They cannot be practically or reliably gathered as they are embedded in the cost of the investment and cannot be separately verified or disclosed. Transaction costs on purchases and sales of equities, futures and options are disclosed in the Statement of Comprehensive Income on pages 27 to 32.

n) Due to/from Redeemable Participating Shareholders

Amounts due to or from Redeemable Participating Shareholders represent redemptions or subscriptions where the shares have been redeemed or subscribed by the Redeemable Participating Shareholder, but as at Statement of Financial Position date the cash has not been paid.

o) Receivable/Payable for Sale/Purchase of Securities

Amounts Receivable or Payable for securities represent sales or purchases where the proceeds or payments have not been received or paid as at Statement of Financial Position date.

3. Derivative Contracts

Typically, derivative contracts serve as components of the Company's investment strategy and are utilised primarily to structure and economically hedge investments to enhance performance and reduce risk to the Company (the Company does not designate any derivatives as hedges for hedge accounting purposes as described under FRS 102).

The derivative contracts that the Company holds are contract for difference ("CFD"), forward currency contracts, futures, options and swap contracts.

Contracts for difference

CFD involve a contract between two counterparties ("buyer" and "seller") which requires that the seller will pay to the buyer the difference between the current value of an asset and its value at a particular contract time. (If the difference is negative, then the buyer pays instead to the seller.) CFD allow traders to take advantage of prices moving up or prices moving down on underlying financial instruments and are often used to speculate on markets. CFD are typically traded "over-the-counter", which means that they are traded "off-exchange". CFD are traded on margin, and the leveraging effect of this increases the risk significantly. The Company will invest in CFD to gain exposure to equity investments and equity market.

The difference between the initial recognition amount and the market value of the open contract is recorded as unrealised gains or losses in the Statement of Financial Position. Realised gains or losses are recognised on the closing or trade date of the contract and are recorded as investment income in the Statement of Comprehensive Income.

Forward Currency Contracts

A forward currency contract involves an obligation to purchase or sell a specific currency at a future date, at a price set at the time the contract is made. Forward currency contracts are valued by reference to a forward price at which a new forward contract of the same size and maturity could be undertaken at the valuation date. The unrealised gain or loss on open forward contracts is calculated as the difference between the contract rate and this forward price and is taken to the Statement of Comprehensive Income.

Futures Contracts

A futures contract is an agreement between two parties to buy and sell a security, index or currency at a specific price or rate at a future date. Upon entering into a futures contract, the Company is required to deposit with a broker an amount of cash or cash equivalents equal to a certain percentage of the contract amount. This is known as 'initial cash margin'. Subsequent payments ('variation margin') are made or received by the Funds each day, depending upon the daily fluctuation in the value of the contract. The daily changes in contract value are recorded as unrealised gains or losses and the Funds recognise a realised gain or loss when the contract is closed. Unrealised gains and losses on futures contracts are recognised in the Statement of Comprehensive Income.

Options

There are two forms of options, put and call options. Put options are contracts sold for a premium that gives one party (the buyer) the right, but not the obligation, to sell to the other party (the seller) of the contract, a specific quantity of a particular product or financial instrument at a specified price. Call options are similar contracts sold for a premium that gives the buyer the right, but not the obligation, to buy from the seller of the option. Options may also be cash settled. The daily changes in contract value are recorded as unrealised gains or losses and the Funds recognise a realised gain or loss when the contract is closed. Unrealised gains and losses on option contracts are recognised in the Statement of Comprehensive Income.

Swaps

A standard swap is an agreement between two counterparties in which the cash flows from two assets are exchanged as they are received for a fixed time period, with the terms initially set so that the present value of the swap is zero. Interest rate swaps involve the exchange by a Fund with another party of their respective commitments to make or receive interest payments (e.g. an exchange of fixed rate payments for floating rate payments). On each payment date under an interest rate swap, the net payments owed by each party, and only the net amount, is paid by one party to the other.

Currency swaps are agreements between two parties to exchange future payments in one currency for payments in another currency. These agreements are used to transform the currency denomination of assets and liabilities.

Swaps (continued)

Credit default swaps are transactions under which the parties' obligations depend on whether a credit event has occurred in relation to the reference asset. The credit events are specified in the contract and are intended to identify the occurrence of a significant deterioration in the creditworthiness of the reference asset. On settlement, credit default products may be cash settled or involve the physical delivery of an obligation of the reference entity following a default. The buyer in a credit default swap contract is obligated to pay the seller a periodic stream of payments over the term of the contract provided that no event of default on an underlying reference asset has occurred. If a credit event occurs, the seller must pay the buyer the full notional value of the reference asset that may have little or no value.

Inflation-linked swaps are agreements between two parties whereby one party pays a fixed rate on a notional principal amount, while the other party pays a floating rate linked to prevailing inflation measurement indices such as Retail Price Index (RPI).

Unrealised gains & losses on Swap contracts are recognised in the Statement of Comprehensive Income. Any swap related income/expenses are recognised as Swap Income and Swap Expense respectively in the Statement of Comprehensive Income.

4. Share Capital

The authorised share capital of the Company is 1,000,000,000,000 shares of no par value initially designated as unclassified shares; the issued share capital of the Company is €2 represented by 2 shares (the 'subscriber shares') issued for the purposes of the incorporation of the Company at an issue price of €1 per share which are fully paid up and which are held by Kames Capital Plc and Kames Capital Management Limited. The unclassified shares are available for issue as Redeemable Participating Shares.

Voting Rights

Subject to any rights or restrictions for the time being attached to any class or classes of shares, on a show of hands every holder who is present in person or by proxy shall have one vote and the holder(s) of subscriber shares present in person or by proxy shall have one vote in respect of all the subscriber shares in issue and on a poll, every holder present in person or by proxy shall have one vote for every share of which he is the holder and every holder of a subscriber share present in person or by proxy shall have one vote in respect of his holding of subscriber shares.

Redeemable Participating Shares

The net assets attributable to holders of Redeemable Participating Shares are at all times equal to the Net Asset Value of the Company. The participating shares which comprise the equity capital of the Company are in substance a liability of the Company to shareholders under the terms of FRS 102 as they can be redeemed at the option of the shareholder.

Participating shares may be redeemed on each dealing date or such other date or dates as the Board of Directors shall from time to time determine (Valuation Day) at the Net Asset Value per share.

Equalisation

The Company will operate grouping for equalisation with respect to Income shares (shares which are entitled to a portion of the Funds ordinary income). Each income class of each Fund will operate its own equalisation account. Shares purchased during a distribution period are called Group 2 Shares. Shares purchased during any previous distribution period are called Group 1 Shares. Group 2 Shares contain in their purchase price an amount called equalisation which represents a proportion of the net income of the Fund that has accrued up to the date of purchase. The amount of equalisation is averaged across all the Shareholders of Group 2 Shares and is refunded to them as part of their first distribution.

5. Taxation

Under current Irish law and practice the Company qualifies as an investment undertaking under Section 739B of the Taxes Consolidation Act 1997 and is not therefore chargeable to Irish tax on its relevant income or relevant gains. No stamp, transfer or registration tax is payable in Ireland on the issue, redemption or transfer of shares in the Company.

Distributions and interest on securities issued in countries other than Ireland may be subject to taxes including withholding taxes imposed by such countries. The Company may not be able to benefit from a reduction in the rate of withholding tax by virtue of the double taxation agreement in operation between Ireland and other countries. The Company may not, therefore, be able to reclaim withholding tax suffered by it in particular countries.

To the extent that a chargeable event arises in respect of a Shareholder, the Fund may be required to deduct tax in connection with that chargeable event and pay the tax to the Irish Revenue Commissioners. A chargeable event can include dividend payments to Shareholders, appropriation, cancellation, redemption, repurchase or transfer of shares, or a deemed disposal of shares every 8 financial years beginning from the date of acquisition of those shares. Certain exemptions can apply. To the extent that Shareholders have appropriate tax declarations in place with the Company there may be no requirement to deduct tax.

Applicant share classes have been registered with the UK tax authorities under the Reporting Fund regime. The HMRC website (www.hmrc.gov.uk/collective/cis-centre.htm) has a list of the applicant share classes.

9. Distribution Policy

It is the current intention of the Directors to declare dividends for the Income share classes on the Strategic Global Bond Fund, the Investment Grade Global Bond Fund[^], the High Yield Global Bond Fund, the Global Equity Income Fund, the Absolute Return Bond Fund^{^^} and the Emerging Market Bond Fund[^] on a quarterly basis on the first Business Days of August, November, February and May. The Directors intend to pay dividends equal to substantially all of the income arising to the Income Share Classes.

As detailed in Note 1, the financial statements for the year ended 31 October 2015 have been prepared to the valuation as at close of business and not the official midday GMT net asset value as has been the case in previous years. As a result, the 31 October 2015 statements are for a slightly extended period and as so include five distributions. Going forward the financial statements will be prepared to close of business of valuation and will include the four quarterly distributions only.

The Company will operate grouping for equalisation with respect to Income Shares Classes. Each class of each Fund will operate its own equalisation account. Shares purchased during a distribution period are called Group 2 Shares. Shares purchased during any previous distribution period are called Group 1 Shares. Group 2 Shares contain in their purchase price an amount called equalisation which represents a proportion of the net income of the Fund that has accrued up to the date of purchase. The amount of equalisation is averaged across all the Shareholders of Group 2 Shares and is refunded to them as part of their first distribution. It may be treated as a return of capital for tax purposes.

11. Fees

The Company may pay out of the assets of each Fund the fees and expenses payable to the Manager, Investment Manager, the Custodian, the Administrator and the Distributor, the fees and expenses of sub-custodians which will be at normal commercial rates, the fees and expenses of the Directors, any other miscellaneous fees such as, all taxes, company secretarial fees, any costs incurred in respect of meetings of Shareholders and marketing and distribution costs.

Such fees, duties and charges will be charged to each Fund in respect of which they were incurred or, where an expense is not considered by the Directors to be attributable to any one Fund, the expense will be allocated by the Directors with the approval of the Custodian, in such manner and on such basis as the Directors in their discretion deem fair and equitable.

In the case of any fees or expenses of a regular or recurring nature, such as audit fees, the Directors may calculate such fees and expenses on an estimated figure for yearly or other periods in advance and accrue the same in equal proportions over any period.

Administration and Registrar Fee

As detailed in the prospectus the Investment Manager pays Administration fees on behalf of the Funds. These fees are paid directly by the Investment Manager to the Administrator, Citibank Europe Plc. The Investment Manager is invoiced directly and pays these fees out of the Investment Manager fee. During the financial year ended 31 October 2015 the amounts paid amounted to USD 942,883 (2014: USD 617,961). At the financial year end USD 98,793 was payable (2014: USD 107,449), this amount is included in the Investment Management fee payable figure on the Statement of Financial Position.

Investment Manager Fees

The fee payable to the Investment Manager (excluding the Performance Fee) will be no more than 1% per annum of the Net Asset Value of the Strategic Global Bond Fund, the Investment Grade Global Bond Fund, the High Yield Global Bond Fund, the Absolute Return Bond Fund, the Global Equity Income Fund, the Active Long Dated Bond Fund, the Equity Market Neutral Fund, the Absolute Return Bond Global Fund, Absolute Return Bond Constrained Fund and Emerging Market Bond Fund including both Income shares and Accumulation shares. The fee payable to the Investment Manager (excluding the Performance Fee) will be no more than 1.5% per annum of the Net Asset Value of the Equity Market Neutral Plus Fund including both Income shares and Accumulation shares.

Such fees shall be calculated daily and payable monthly in arrears. The Investment Manager shall also be entitled to be reimbursed out of the assets of each Fund for reasonable out-of-pocket expenses incurred by the Investment Manager in the performance of its duties.

The Investment Manager Fees incurred and payable are presented in the Statement of Comprehensive Income and Statement of Financial Position on pages 27 to 32 and 33 to 38, respectively.

Custodian Fee

The fee payable to the Custodian, for custodial services provided to the Company, will not exceed 0.5% per annum of the Net Asset Value of each Fund.

The Custodian will also be entitled to receive any out-of-pocket expenses incurred (including any transaction charges or sub-custodian fees at normal commercial rates).

Performance Fee

In addition to the Investment Manager Fees, a Performance Fee is payable to the Investment Manager of the Equity Market Neutral Plus Fund in certain circumstances, as set out below. The Investment Manager may agree at its discretion to waive the Performance Fee or a portion of the Performance Fee with respect to certain Shareholders' investment in the Fund. Any such waiver or reduction will not entitle other Shareholders to a similar waiver. The Performance fee shall be payable annually in arrears.

High Water Mark is a measure used to ensure that a Performance Fee is only charged when there has been an increase in value over the Performance Period. For the Fund, the High Water Mark is the Net Asset Value per Share when a Performance Fee last crystallised or, if higher, the Initial Issue Price.

Hurdle Price is one of the prices which has to be exceeded (the other being the High Water Mark) before a Performance Fee will accrue. For the Fund, the Hurdle Price at the start of a Performance Period is equal to the High Water Mark. The Hurdle Price on each subsequent day of that Performance Period is calculated on a cumulative basis by multiplying the previous day's Hurdle Price by one plus the relevant Hurdle Rate.

Hurdle Rate is the relevant cash rate of return applicable in respect of the relevant Share class (as set out in the following table) on the each day during the Performance Period, divided by 365 (or 366 in a leap year). The Investment Manager may amend the relevant cash rate of return upon 60 business days' written notice to Shareholders. For the purpose of the Hurdle Rate EURIBOR is the Euro Interbank Offered Rate and LIBOR is the London Interbank Offered Rate:

Outperformance is the amount by which the Net Asset Value per Share exceeds the higher of the High Water Mark and the Hurdle Price.

Performance Period is the period over which the Performance Fee is calculated and is the period ending at the valuation point on 31st October of each financial year. The first Performance Period for each Share Class will start on the launch date of that Share Class. The Performance Period shall be deemed to end on the date on which any Shares are redeemed.

The Performance Fee is calculated as 15% of the Outperformance. It is calculated and accrued daily by the Administrator, subject to verification by the Custodian. It is calculated at Share Class level (rather than, for example, at Fund level or individual Shareholder level).

Using a High Water Mark in the calculation of Outperformance ensures that Shareholders are only charged a Performance Fee once on any performance generated by the Fund. This means that Shares purchased when the Net Asset Value per Share is less than the High Water Mark will not be subject to any Performance Fee until the date on which the Net Asset Value per Share exceeds the High Water Mark (or, if higher, the Hurdle Price). Where the Net Asset Value per Share is below the High Water Mark at the end of a Performance Period, the High Water Mark will remain unchanged and will not be re-set downwards.

The Net Asset Value per Share and the Hurdle Rate may differ in different Share Classes. This means that the amount of Performance Fee payable in respect of a Performance Period may differ between Share Classes. The Hurdle Rate will vary from day to day over the Performance Period as the relevant cash rate of return (specified in the table above) changes.

The Performance Fee shall not fall below zero. There is no limit on the amount of the Performance Fee which may be payable in a Performance Period. Once a Performance Fee has been paid, it will not be repaid by the Investment Manager regardless of the future performance of the Fund.

The Performance Fee is based on net realised and net unrealised gains and losses at the end of each Performance Period. As a result, a Performance Fee may be charged on gains which are not subsequently realised. Once a Performance Fee has been paid, no refund will be made.

Where a Performance Fee is payable to the Investment Manager, it will already be reflected in the Net Asset Value per Share. This means that payment of the Performance Fee to the Investment Manager will not result in a sudden drop in the Net Asset Value per Share.

The Performance Fee will be calculated as part of the Net Asset Value per Share, after any fees and expenses have been deducted but before any Dilution Adjustment has been made.

Where an investor holds Shares for part of a Performance Period, a Performance Fee will be payable by the relevant Share Class if there is Outperformance over the Performance Period even if, during the part of the Performance Period in which the investor owns Shares, there is no Outperformance. However, any Performance Fee payable will only accrue on those days on which there is Outperformance.

Where Shares are cancelled during a Performance Period and, at the relevant valuation point, the Net Asset Value per Share is above the High Water Mark and the Hurdle Price, any Performance Fee accrued and reflected in the price of those Shares will become payable to the Investment Manager. Any such Performance Fee paid to the Investment Manager will not be repaid even if, at the end of the relevant Performance Period, a Performance Fee would not have been payable in respect of such Shares if they had continued to be held to the end of such Performance Period.

The Performance Fee incurred and payable is presented in the Statement of Comprehensive Income and Statement of Financial Position on pages 27 to 32 and 33 to 38, respectively.

Distributor Fee

In addition to the preliminary charge that may be paid to the Distributor, the fee payable to the Distributor for its services in the distribution of shares of the Fund shall not exceed 1% per annum of the Net Asset Value attributable to the Class A Shares. The Distributor may, at its sole discretion and in accordance with applicable laws and regulations, (i) pay commission to financial intermediaries including but not limited to sub-distributors, intermediaries and advisers who refer and/or advise prospective investors out of the Distributor's fee as set out above and/or (ii) waive the Distributor Fee for certain prospective investors based on factors deemed appropriate by the Distributor.

Directors Fees

Only Directors who are not employees of the Aegon group of companies and Kames group of companies will be entitled to remuneration for their services as Director. The fees shall not exceed EUR 20,000 per annum or such other amount as may be approved by a resolution of the Directors or the Shareholders in the general meeting.

All Directors will be entitled to be reimbursed out of the assets of the Funds for out of pocket expenses incurred in discharging their duties as Directors. The Directors fees incurred by the Company for the financial year ended 31 October 2015 amounted to USD 45,437 (2014: USD 46,998).

12. Risks Associated with Financial Instruments

Risk is inherent in the activities of each Fund but it is managed through a process of ongoing identification, measurement and monitoring, subject to risks limits and other controls. The Funds are exposed to market risk (which includes currency risk, interest rate risk and market price risk), credit risk and liquidity risk arising from the financial instruments it holds.

The main risks arising from financial instruments and the policies for managing these risks are stated below. These policies have been applied throughout the period under review.

Market Price

The main risk arising from each Fund's financial instruments is market price. Market price risk is the risk that the value of the Funds' investments will fluctuate as a result of changes in market price caused by factors other than interest rate or foreign currency movements. Market price risk arises mainly from uncertainty about future prices of financial instruments that the Fund might hold. It represents the potential loss the Funds might suffer through holding market positions in the face of price movements. The Funds' investment portfolios are exposed to market price fluctuations, which are monitored by the investment manager in pursuance of the stated investment objectives, and policies as set out in the Prospectus. In addition, the Funds are also exposed to unfavourable market prices changes of the underlying financial instruments in case of contracts for difference. The Funds may incur a significant loss if the value of the underlying instruments falls below the value of a particular contract.

Adherence to the investment guidelines and to investment and borrowing powers set out in the instrument of incorporation, the Prospectus and the notices issued by the Central Bank mitigates the risk of excessive exposure per industry to any particular type of security or issuer.

Fair Value Estimation

FRS 102 duplicates the three-level fair value measurement hierarchy in FRS 29, however there are distinct differences in these classifications as well. The fair value hierarchy of each Fund's financial assets and liabilities measured at 31 October 2014 using FRS 29 has been disclosed in the Unaudited Supplementary Notes on pages 241 to 243 for comparative purposes.

FRS 102 requires the Funds to classify fair value measurements using a fair value hierarchy that reflects the significance of the inputs used in making the measurements. The fair value hierarchy has the following levels:

- Level A – Quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level B – When quoted prices are unavailable, the price of a recent transaction for an identical asset provides evidence of fair value as long as there has not been a significant change in economic circumstances or a significant lapse of time since the transaction took place.
- Level C – If the market for the asset is not active and recent transactions of an identical asset on their own are not a good estimate of fair value, an entity estimates the fair value by using a valuation technique, based on observable market data or non-observable market data.

The level in the fair value hierarchy within which the fair value measurement is categorised in its entirety is determined on the basis of the lowest level input that is significant to the fair value measurement in its entirety. For this purpose, the significance of an input is assessed against the fair value measurement in its entirety. If a fair value measurement uses observable inputs that require significant adjustment based on unobservable inputs, that measurement is a level B or C measurement. Assessing the significance of a particular input to the fair value measurement in its entirety requires judgement and consideration of factors specific to the asset or liability.

The value of fixed interest securities may be affected by such movements in the future. Interest receivable on bank deposits and payable on bank overdrafts will be affected by fluctuations in interest rates, as will Floating Rate Bonds. All other assets and liabilities of the Funds are non-interest bearing.

Liquidity Risk

Liquidity risk is defined as the risk that the Company may not be able to settle or meet its obligations on time or at a reasonable price. The Company is exposed to daily cash redemptions of Redeemable Participating Shares. Redeemable Participating Shares are redeemed on demand at the holder's option based on the Company's net assets value per share at the time of redemption. The Redeemable Participating Shares are carried at the redemption amount that is payable at the reporting date if the holder exercises the right to put the share back to the Company.

The Company manages its liquidity risk by investing primarily in marketable securities.

The assets of the Company are considered to be readily realisable. Assets from a Fund may need to be sold if insufficient cash is available to finance such cancellations.

The Company may repurchase some proportion or all shares held by an investor at the Repurchase Price on the relevant Dealing Day, subject to the following exceptions:

(a) Where the total of repurchase requests on any Dealing Day exceeds 10% of the Net Asset Value of shares of any Fund in issue at the Valuation Point, the Company may scale down pro rata the number of shares to be repurchased in response to each request to ensure that the 10% limit is not exceeded. Any unfulfilled balance of repurchase requests will be carried forward to the next Dealing Day and so on thereafter until each request has been dealt with in full. Requests for repurchase that have been carried forward from an earlier Dealing Day will be dealt with in priority to later requests.

(b) If in respect of any single repurchase, monies amount to more than 5% of the Net Asset Value of the Fund at the Valuation Point for the Dealing Day, the Company has the power to divide in specie all or any part of the Assets of the relevant Fund, and has the right to elect by notice in writing to the investor to appropriate and transfer Assets to him in full or part satisfaction of the Repurchase Price.

The table below analyses each of the Fund's financial liabilities into relevant maturity groupings based on the remaining period at the Statement of Financial Position date to the contractual maturity date. The amounts in the table are the contractual undiscounted cash flows. Balances due within 12 months equal their carrying balances, as the impact of discounting is not significant.

The Company has granted the Custodian a specific lien, and the right to grant such lien to Citibank N.A., London Branch, on the particular Securities which, in accordance with the Company's specific instructions, have as global custodian been purchased or sold for the account of the Company and in respect of which the Custodian, or Citibank N.A., London Branch has, in its absolute discretion, extended or granted financial accommodation or otherwise advanced moneys to the Company for the purposes of such purchase or sale until satisfaction or discharge of all liabilities of the Company to the Custodian, including any fees, expenses or credit exposures incurred in connection with the such purchase or sale.

The Strategic Global Bond Fund, Investment Grade Global Bond Fund, High Yield Global Bond Fund, Absolute Return Bond Fund, Global Equity Income Fund, Active Long Dated Fund, Equity Market Neutral Plus Fund, Equity Market Neutral Fund, Absolute Return Bond Global Fund, Absolute Return Bond Constrained Fund and Emerging Market Bond Fund hold derivatives, including options, futures, forwards, and swaps, which are not rated. The funds also hold pledged and received collateral. Details of Counterparties to these derivative positions and their respective credit ratings are disclosed in the Portfolio of Investments on pages 159,164,169,175,177,182,185,189,195,199 and 202 for the Funds, respectively. The Strategic Global Bond Fund, Absolute Return Bond Fund, Active Long Dated Fund and Absolute Return Bond Global Fund hold Credit Default Swaps. The Company's maximum gross exposure to credit risk is approximately the carrying value of the financial assets plus nominal value of the credit default swaps (protection sold) in the Statement of Financial Position. For Credit Default Swaps in which the Company is selling protection the total gross nominal value of Credit Default Swaps (protection sold) is EUR 378,000,000 (2014: EUR 121,000,000 and USD 26,000,000) as at 31 October 2015. The percentage of these securities' market values over the net asset of each relevant Fund is disclosed in the Portfolio of Investments on pages 153 to 202.

The Kames Composite Rating uses ratings from Moody's, Fitch and S&P. A score is assigned to each rating based on an IBOXX static table and the average score is calculated and translated to a rating based on the same IBOXX static table. If there is no rating from any of the agencies, the IBOXX rating is used as the Kames Composite rating.

The IBOXX rating was not used during the financial year ended 31 October 2015 and 31 October 2014.

Derivatives

Some of the Funds may also enter into derivative transactions in the form of contracts for difference, forward foreign currency contracts, swaps, futures and CFD. Forward foreign currency contracts are used to manage currency risk arising from holdings of overseas securities, contracts for difference, swaps (including Credit Default Swaps), options and future contracts, as well as CFD contracts, are used to manage market risks arising from the Funds investment activities.

The Absolute Return Bond Fund enters into financial derivative instruments (including forward foreign currency contracts, futures, and swaps) for investment purposes.

13. Related Parties

Parties are considered to be related if one party has the ability to control the other party or exercise significant influence over the other party in making financial or operational decisions or if one party is a member of the key management personnel of the other party.

Global Derivative Exposure (Unaudited)

The Investment Manager has assessed the risk profiles of the Funds on the basis of the Investment policy, strategy and the use of Financial Derivative Instruments. Based on the risk profile, the Investment Manager has determined that the method for the calculation of the global exposure to financial derivative instruments for all Funds will be the Value-at-Risk ("VaR") approach.

Value at Risk (VaR), as a figure, is the maximum loss not exceeded with a given probability defined as the confidence level, over a given period of time. VaR is widely applied in finance for quantitative risk management for many types of risk.

The manager reviews the levels of investment risk on a no less than monthly basis, with particular emphasis on VaR and leverage, where the latter exists. The Strategic Global Bond Fund, the Investment Grade Global Bond Fund, the High Yield Global Bond Fund, the Absolute Return Bond Fund and the Emerging Market Bond Fund use the absolute VaR approach. The Global Equity Income uses the relative VaR approach.

VaR has three parameters:

- The time horizon (period) of the VaR. The maximum loss is considered over this period. Typical periods using VaR are 1 day, 10 days, or 1 month.
- The confidence level is the interval estimate in which the VaR would not be expected to exceed the maximum loss. Commonly used confidence levels are 99% and 95%. (Confidence levels are not indications of probabilities.) Here a 95% confidence interval is used (2014: 95%).
- Calculation methods used are parametrical (variance-covariance approach), historical or Monte Carlo. In this case the investment manager has utilised the historical approach.

Limitations

Whilst VaR is a good general risk measure it is acknowledged it does have certain limitations, including:

- The measure is a point-in-time calculation, reflecting positions as recorded at that date, which do not necessarily reflect the risk positions held at any other time.
- VaR is a statistical estimation and therefore it is possible that there could be, in any period, a greater number of days in which losses could exceed the calculated VaR than implied by the confidence level.
- Although losses are not expected to exceed the calculated VaR on 95% of occasions, on the other 5% of occasions losses will be greater and might be substantially greater than the calculated VaR.
- The period over which positions are expected to be held may differ and so will the modelled losses incurred.
- A look back period of 5 financial year means that any return that has not been evidenced in this time period will not be present in the distribution.
