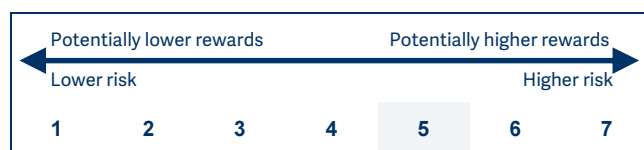
KEY INVESTOR INFORMATION

This document provides you with key investor information about this fund. It is not marketing material. The information is required by law to help you understand the nature and risks of investing in the fund. You are advised to read it so you can make an informed decision about whether to invest.

OBJECTIVES AND INVESTMENT POLICY

Objective	The fund aims to increase the value of shareholders' investments primarily through capital growth.
Investment Policy	<ul style="list-style-type: none"> The fund is actively managed. The fund invests principally (a minimum of 80%) in equities and equity-related derivatives of companies that are listed or headquartered or that exercise the predominant part of their economic activities in the USA. The fund uses derivatives (financial instruments whose value is linked to the expected price movements of an underlying asset) for investment purposes to take both long and short positions in individual companies. At times, the fund may also use equity index futures and/or options (long or short) in order to vary the level of volatility and/or market exposure in the fund. Total derivatives (longs and shorts) are likely to represent a significant proportion of the fund's gross exposure to companies, which will typically lie in a range of 130-160% of net asset value but which may potentially be as high as 200%. The investment manager uses derivatives to select stocks that may benefit from falling, as well as rising, share prices. However the fund's ability to have a gross exposure to companies of more than 100% of its net asset value means that the fund has the potential both to generate greater returns and to experience greater losses than if the fund was restricted to a gross exposure of 100% of its net asset value. The fund's net exposure to companies will typically lie in the range of 85-110% (longs minus shorts) depending on market conditions. A significant proportion of the net asset value of the fund will be held in cash due to the level of derivative use. The fund will hold money market instruments, cash and near cash, subject to the limits set out in the investment restrictions. In order to allow the fund to be able to manage counterparty risk, the fund may also invest its cash in government securities. These securities will generally be less than 1 year maturity. Hedged shares allow the use of currency hedging transactions to reduce the effect of fluctuations in the rate of exchange between the currency or currencies in which the assets of the portfolio are invested and the US dollar. <p>The fund may also invest in:</p> <ul style="list-style-type: none"> China A-Shares through Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect, up to a maximum of 10% of the fund's net asset value. Derivatives and other techniques for hedging and for efficient portfolio management. The fund's derivatives may include, but are not limited to, contracts for difference, futures, options, swaps and forward currency contracts. Other collective investment schemes, up to a maximum of 10% of the fund's net asset value.
Benchmark information	<ul style="list-style-type: none"> S&P 500 TR (Hedged to EUR) <p>The benchmark is a point of reference against which the performance of the fund may be measured. Management of the fund is not restricted by this benchmark. The deviation from the benchmark may be significant and the portfolio of the fund may at times bear little or no resemblance to its benchmark.</p>
Other Information	<ul style="list-style-type: none"> Hedging: The costs and benefits of currency hedging transactions will apply to hedged classes. This includes the costs of hedging and the allocation of any gains and losses resulting from the hedging transactions. Dealing frequency: Open Monday to Friday except on Luxembourg public holidays. Instructions received before 13.00 CET will be processed at 16.00 CET on the same day. Distribution policy: This is an accumulation class. Income received is reinvested in the value of the fund.

- Currency risk:** The fund's assets may be priced in currencies other than the fund base currency. Changes in currency exchange rates can therefore affect the fund's value.
- Derivatives risk:** The fund may invest in derivatives with the aim of profiting from falling ('shorting') as well as rising prices. Should the asset's value vary in an unexpected way, the fund value will reduce.
- Cash risk:** The fund may hold a large amount of cash. If it does so when markets are rising, the fund's returns could be less than if the cash was fully invested in other types of assets.

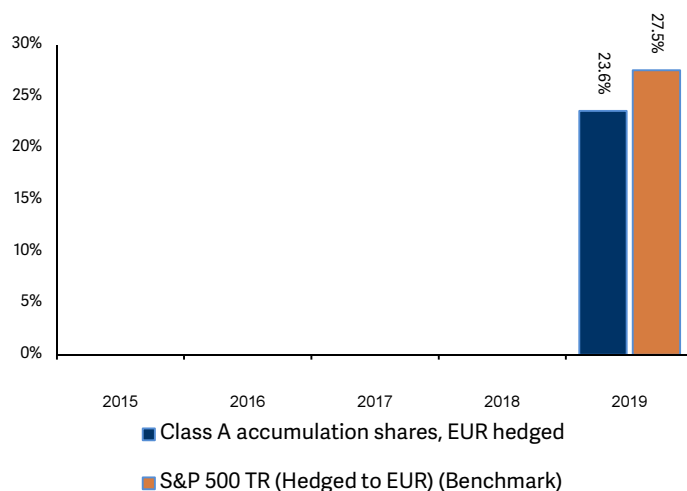
