What is this product?

Type: The Fund is a mutual investment fund qualifying as an undertaking for collective investment in transferable securities (UCITS) established under Luxembourg law.

Term: This product has no specific maturity date.

Azimut Investments S.A. is entitled to terminate the contract unilaterally.

Azimut Investments S.A. may terminate the contract unilaterally inter alia in case of liquidation or merger of the Sub-fund. Please refer to the prospectus for additional informations on early termination circumstances.

Objectives

The Sub-fund's investment objective is to achieve long-term capital growth.

The Sub-fund aims to achieve its investment objective by actively investing in commodities indices.

The Sub-fund indirectly invests at least 50% of its net assets in commodities through derivative financial instruments on commodities indices, UCITS and/or other UCIs investing in derivatives on commodities indices, ETFs and/or ETCs provided that they qualify as transferable securities.

The Sub-fund may also invest in total return swaps (TRS). Gross exposure to TRS shall not exceed 200% of the fund's net assets and it is expected that such exposure will remain between 50% and 200% of the fund's net assets. The strategies underlying the TRS are long only or long/short on financial indices with exposure to commodities.

The Sub-fund is expected to use only a portion of its assets to achieve the desired exposure to the assets mentioned above owing to the use of derivatives. As a result, the remaining assets of the fund may be invested in debt securities, money market instruments and cash in order to provide additional total income over the long term.

The Sub-fund may also invest up to 80% of its net assets in debt securities and money market instruments issued by developed market issuers, up to 30% of its net assets in debt securities and money market instruments issued by emerging market issuers and up to 30% of its net assets in debt securities with a sub-investment grade rating.

The Sub-fund uses the main derivative financial instruments for investment purposes in order to implement its investment policy and/or for hedging purposes. The Sub-fund aims at maintaining a leverage effect lower than 300%, calculated on the total of all derivative financial instruments' notional amounts. Gross exposure to TRS shall not exceed 200% of the fund's net assets.

The Sub-fund is actively managed. The 90% Bloomberg Commodity Total Return index + 10% Bloomberg US Treasury Bill Index is used for the purpose of the fulcrum adjustment as well as VAR (Value at Risk) monitoring.

The Sub-fund qualifies as Article 6 of SFDR Regulation.

You may request the redemption of your units on a daily basis.

Dividends are not intended to be distributed. Any income derived from the product is reinvested.

Intended retail investor: The Sub-fund is intended to be marketed to professional investors and retail investors who are able and willing to invest in a commodity-focused Sub-fund, with a high risk grading and to a get a return over 7 years.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 7 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay voit.

We have classified this product as 4 out of 7, which is a medium risk class. This classification rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Be aware of currency risk. The currency of this product may be different from that of your country. As you may receive payments in the currency of this product and not that of your country, the final return you will get will depend on the exchange rate between these two currencies. This risk is not considered in the indicator shown above.

Other risks materially relevant to the product not included in the summary risk indicator: emerging market risk, currency risk, risk associated with the "long/short" strategy, risks associated with total return swaps, risks associated with commodities.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

What happens if Azimut Investments S.A. is unable to pay out?

The assets of the product are held in safekeeping by BNP Paribas, Luxembourg Branch (the "Depositary"). In the event of the insolvency of Azimut Investments S.A. (the "Management Company"), the product's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the product may suffer a financial loss. This risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the product. The Depositary will also be liable to the product and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

There is no investor compensation or guarantee scheme in the case of default of the Management Company or the Depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- In the first year, you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 7 years

The recommended holding period has been defined by taking into account the expected composition of the Sub-fund's portfolio, as well as long-term averages of return and risk for relevant asset classes and markets.

You may request the redemption of your units on a daily basis. You may receive less than expected if you cash in earlier than the recommended holding period. The recommended holding period is an estimate and must not be taken as a guarantee or an indication of future performance, return or risk levels.

Holders of units may request redemption at any time. Redemption will be performed by the Custodian within five bank business days following calculation of the applicable net asset value.
