

# Key Investor Information

This document provides you with key investor information about this Fund. It is not marketing material. ## Local Emerging Bond, a subfund of the SICAV BNP Paribas Funds, short named as BNP Paribas

This Fund is managed by BNP PARIBAS ASSET MANAGEMENT Luxembourg, part of the BNP Paribas Group.

## Objectives and investment policy

The Fund is actively managed and as such may invest in securities that are not included in the index which is JPM EMBI Global Diversified (RI). The benchmark is used for performance comparison only. The Fund is not benchmark constrained and its performance may deviate significantly from that of the benchmark.

The Fund seeks to increase the value of its assets over the medium term by investing in bonds and other debt instruments issued by emerging countries or companies from or operating in emerging countries. In the management process, emphasis is put on local currencies fluctuations. Countries exposures are weighted according to a diversification process implemented by the Investment Management team.

The Fund may be invested into debt securities traded on the China Interbank Bond market.

It is actively managed and as such may invest in securities that are not included in the index JPM GBI-EM Global Diversified (RI) (the benchmark). Nevertheless, due to similar geographical and thematic constraints, investors should be aware that the Fund's risk and return profile may, from time to time, be comparable to the risk and return profile of the benchmark.

The investment team applies also BNP PARIBAS ASSET MANAGEMENT Sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria such as but not limited to reduction of emissions of greenhouse gas, respect of human rights, respect of minority shareholders rights, at each step of the investment process of the Fund.

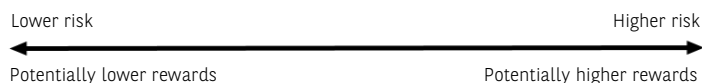
An extra-financial strategy may comprise methodological limitations such as the ESG Investment Risk as defined by the asset manager.

Environmental, social and governance (ESG) criteria contribute to, but are not a determining factor in, the manager's decision making.

Incomes are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus.

- Why is the Fund in this specific category?  
The risk category is justified by the investment mainly in Interest Rate instruments. The investor's attention is drawn to the fact that an increase in interest rates results in a decrease in the value of investments in bonds and debt instruments and more generally fixed income instruments.
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- **Credit Risk:** This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- **Operational and Custody Risk:** Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
- **Risk related to investments in Mainland China:** such investments are subject to additional risks that may be the result of political, economic, social, tax, market and operational factors specific to the Chinese Market.

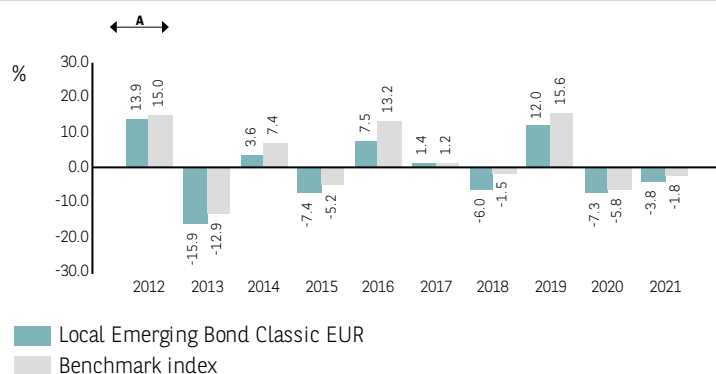
(\*) The **ongoing charges** figure is based on past expenses determined as of 31 October 2021.
