### Objectives and investment policy

#### Objectives

- Increase the value of your investment over the short to medium term.

#### Investment portfolio

- The sub-fund invests mainly in a portfolio which consists of shares of investment funds, shares and bonds and whose makeup corresponds to a moderate risk level. The sub-fund may also invest in structured financial products that are compatible with the investment policy. The sub-fund has no geographic, industry or currency restrictions.
- In order to take advantage of or hedge against market fluctuations, or for effective portfolio management, the sub-fund may make use of derivative instruments.

#### Investment process

- **The sub-fund is actively managed without reference to any benchmark index.**  
The manager selects between different investment classes and countries on the basis of macro-economic criteria. Next, the manager analyses and selects undervalued companies with growth potential.

#### Investor profile

- This sub-fund is geared towards investors who understand the sub-fund's risks and wish to invest for a minimum period of two years.

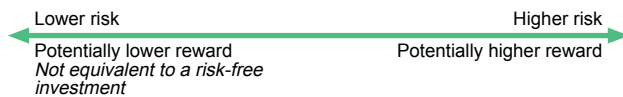
You may buy or sell shares from the sub-fund on any business day in Luxembourg.

This sub-fund issues accumulation shares (shares for which all income is reinvested in the sub-fund) and income shares (shares that pay income to their holder).

#### Important terms

- **Share** Financial security that corresponds to a portion of a company's capital and generally gives entitlement to dividends.
- **Derivative instrument** Any financial security whose value is linked to one or more interest rates, indices, shares, currencies, raw materials or other underlying security.
- **Bond** Financial security issued by a company, government or entity that generally gives entitlement to interest.
- **Structured financial product** Financial product whose value and remuneration are linked to a combination of underlying financial securities.

- The value of an investment in a sub-fund increases or decreases over time. At the time of resale, the price of your shares may be lower than the original price and therefore result in a loss. If you invest in a sub-fund whose currency is different from your own, fluctuations in the exchange rate may also reduce your profits or increase your losses.
- The above risk level is calculated on the basis of the sub-fund's medium-term volatility (i.e., on the basis of actual changes in its value over the last five years or on the basis of a simulation if the sub-fund was launched within that period). The sub-fund's volatility may rise or fall over time, thus potentially altering its risk level.
- The sub-fund's risk level reflects the following factor(s):
  - Bond investments present a lower volatility and degree of risk than shares and a higher volatility and degree of risk than monetary instruments.

The risk level does not reflect possible effects of atypical market conditions or unpredictable events which may amplify risks or trigger other risks such as:

- **Credit risk** Risk related to bonds in which the bonds no longer have any value when the bond issuer is unable to repay its debt on the set maturity date.
- **Liquidity risk** Some financial securities may be impossible to sell quickly at a given moment or may be sold at a discount.
- **Risk management** Under abnormal market conditions, typical management techniques may be ineffective or disadvantageous.
- **Risk of derivative instruments** Some derivative instruments may increase the sub-fund's volatility or put the sub-fund at risk of losses that are greater than the price of these derivative instruments.
- **Operational risks** In any market, particularly emerging markets, the sub-fund may lose part or all of its money in case of any default in the safekeeping of the assets, fraud, corruption, political activities or any other undesirable event.
- **Counter-party risk** The sub-fund may lose money following a default by a market player with which it transacts.

## Charges

The charges and fees you pay are used to pay the costs of running the sub-fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

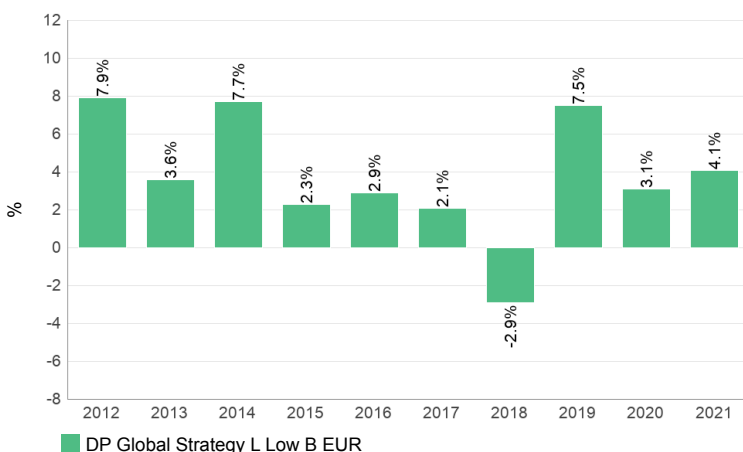
