## What is this product?

#### Type

Distribution share of a sub-fund of DPAM B, a public SICAV under Belgian law. The shares of the sub-fund are distribution shares, which give right to a dividend. All income earned by the product can be distributed.

### Duration

Indefinite. This product does not have a fixed maturity date.

### **Objectives**

**Objective:** The objective of the sub-fund is to offer shareholders exposure to debt securities denominated in euros that are rated at least investment grade. These securities are selected on the basis of a strict methodology for compliance with environmental, social and governance (ESG) criteria. The sub-fund promotes a combination of environmental and social aspects within the meaning of Article 8 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector, and must contain a minimum proportion of sustainable investments within the meaning of the same Regulation. This is an actively managed sub-fund, which means that the portfolio manager does not aim to replicate the performance of a benchmark.

**Investment policy:** The sub-fund invests mainly in bonds and/or other fixed-rate or floating-rate debt securities (including, but not limited to, perpetual notes and zero-coupon bonds), denominated in euros, issued by companies and with (or whose issuers have) an investment grade rating. Investment grade ratings are between AAA and BBB- on the Standard & Poor's and Fitch scale, and between Aaa and Baa3 on the Moody's scale.

The selection is based on a methodology that, across the entire portfolio, a) excludes companies that are not in compliance with certain global standards, including the UN Global Compact (human rights, labour, environmental protection and anti-corruption), b) excludes companies that are involved in controversial activities (tobacco, gambling, thermal coal, etc.), c) excludes companies involved in major ESG controversies (incidents, allegations related to environmental, social, governance issues), and d) filters the universe according to a screening process based on the quality of the ESG profile of companies, assessed by non-financial rating agencies. Finally, for the portion of investments with a sustainable objective, impact research and sustainability themes ensure that the company's products and/or services finance – in proportion to its turnover – sustainable development. **Derivative products:** The sub-fund may, on an optional basis, use derivatives such as options and/or futures contracts ("futures" and/or "forwards") in order to achieve the investment objectives and/or for risk hedging purposes (hedging or exposure of/to interest rate and credit risks).

Benchmark: iBoxx Euro Corporate Bond All Maturities index.

**Use of the benchmark:** The benchmark is used to compare performance. The selection and weighting of the assets in the sub-fund's portfolio may differ significantly from the composition of the benchmark.

**Subscription/Redemption:**You can exchange your shares in this sub-fund for shares in another sub-fund. For more information on this subject, please refer to the information in the prospectus under the heading "Information about the shares and trading of the shares".

#### Intended Retail Investor

This product is intended for investors with an investment horizon of 3 years meet the criteria for access to this share class described in the prospectus and that:

- have sufficient knowledge and experience in the markets for bonds, other debt securities and funds, and understand the risks of the product
- are seeking exposure to debt securities denominated in euros and rated investment grade
- are interested in an investment that promotes environmental and social characteristics with a minimum proportion of sustainable investments
- can suffer a loss of generally less than 10% per year

DPAM B is an undertaking for collective investment in transferable securities incorporated in Belgium (the Home Member State of the SICAV), which complies with the requirements of Directive 2009/65/EC and which is subject to prudential supervision by the FSMA.

In accordance with the applicable legal provisions, the assets of the subfund are segregated from the assets of the other sub-funds of the SICAV, which means that the rights of the investors and other creditors of this subfund are limited to the assets thereof.



### What are the risks and what could I get in return?

### Risk Indicator

The risk indicator assumes that you will hold the product for 3 years.

We have classified this product as 3 out of 7, which is a medium-low risk class. In other words, the potential losses related to the future performance of the product are below low and average.

Investing in this product also entails risks that are materially relevant but not included in the risk indicator:

- Concentration risk: The portfolio is concentrated on euro-denominated corporate bonds.
- Liquidity risk: The sub-fund invests primarily in investment grade bonds that are considered readily marketable. Liquidity may fall during periods of market tension and transaction costs may rise significantly.
- Inflation risk: The sub-fund invests primarily in fixed income securities. A
  rise in inflation could cause the value of the assets in the portfolio to fall.

This product does not include any protection from future market performance so you could lose some or all of your investment.

#### Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product and/or a suitable benchmark over the last 10 years.

## What happens if DPAM is unable to pay out?

The assets of the sub-fund are held with the Custodian and maintained separate from the other assets held by the Custodian.

In the event of a default by DPAM or any other sub-fund of the SICAV, neither of them may use the funds of the product to pay their debts.

However, your investment is not protected by an indemnification or guarantee mechanism.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

If you change sub-funds, you will pay any difference between the marketing fee for the sub-funds in question.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year, you would get back the amount that you invested (0 % annual return)
- the other holding periods we have assumed the product performs as shown in the moderate scenario
- that EUR 10,000 is invested

# How long should I hold it and can I take money out early?

The recommended holding period is 3 years.
