This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

A sub-fund of DPAM B, a public SICAV under Belgian law

DPAM B is managed by the management company DPAM which acts in that capacity within the meaning of Directive 2009/65/EC.

Competent authority: The Financial Services and Markets Authority (FSMA) is responsible for the supervision of DPAM in relation to this Key Information Document.

This product is authorised in Belgium.

DPAM is authorised in Belgium and regulated by the FSMA.

What is this product?

Type

Distribution share of a sub-fund of DPAM B, a public SICAV under Belgian law. The shares of the sub-fund are distribution shares, which give right to a dividend. All income earned by the product can be distributed.

Duration

Indefinite. This product does not have a fixed maturity date.

Objectives

Objective: The objective of the sub-fund is to offer investors exposure to debt securities denominated in any currency, whose interest payments and/or capital redemption depend on the movement in inflation in a given country or geographical region. It is an actively managed sub-fund, which means that the portfolio manager does not aim to replicate the performance of a benchmark.

The sub-fund does not aim for sustainable investment but promotes environmental and social aspects within the meaning of Article 8 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector. It does not have a sustainable investment objective.

Investment policy: The sub-fund invests mainly (at least 75% of net assets), without restriction as to sectors, in bonds and/or other debt securities, at fixed or floating rates, (in any currency), where payment of interest and/or repayment of capital depends on the evolution of inflation in a country or geographical region. These securities are issued (or guaranteed) by a State (including its regional public authorities) or by international or supranational public bodies or by institutions or agencies held by one or more public actors and charged with public or general interest missions or covered by a mechanism guaranteeing priority repayment in the event of the issuer's default. The sub-fund applies binding investment restrictions to (a) companies that do not comply with Global Standards, (b) companies involved in controversial activities, and (c) companies involved in controversies of maximum severity. It has been granted a derogation and may invest up to 100% of its assets in different issues of transferable securities and financial instruments issued or guaranteed by one of the following States: Germany, France, US, Brazil, UK, Canada, Japan, Australia, Sweden, Denmark and Italy providing they are spread among at least issues, with none of them exceeding 30% of the sub-fund's net assets.

Derivative products: The sub-fund may, on an optional basis, use derivatives such as futures and/or forwards in order to achieve the investment objectives and/or for hedging purposes (hedging of or exposure to the risks associated with certain markets).

Benchmark: Bloomberg Universal Inflation Linked GDP Weighted IG.

Use of the benchmark: The benchmark is used to compare performance. The selection and weighting of the assets in the sub-fund's portfolio may differ significantly from the composition of the benchmark.

Subscription/Redemption: You can exchange your shares in this sub-fund for shares in another sub-fund. For more information on this subject, please refer to the information in the prospectus under the heading "Information about the shares and trading of the shares".

All share subscription or redemption requests may be made prior to 3:00 p.m. (Belgian time) on each business day to Banque Degroof Petercam SA.

Intended Retail Investor

This product is intended for investors with an investment horizon of 3 years meet the criteria for access to this share class described in the prospectus and that:

- have sufficient knowledge and experience in the markets for bonds, other debt securities and funds, and understand the risks of the product
- The objective of the fund is to offer investors exposure to debt securities denominated in any currency, whose interest and/or capital redemption depend on the movement in inflation in a given country or geographical region.
- are interested in an investment that promotes environmental and social characteristics without a sustainable investment objective
- can suffer a loss of generally less than 10% per year

The Key Information Document describes a share class of the sub-fund DPAM B Bonds Global Inflation Linked of the SICAV DPAM B.

DPAM B is an undertaking for collective investment in transferable securities incorporated in Belgium (the Home Member State of the SICAV), which complies with the requirements of Directive 2009/65/EC and which is subject to prudential supervision by the FSMA.

In accordance with the applicable legal provisions, the assets of the sub-fund are segregated from the assets of the other sub-funds of the SICAV, which means that the rights of the investors and other creditors of this sub-fund are limited to the assets thereof.

The prospectus and periodic reports are drawn up for all the sub-funds of the SICAV.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you will hold the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. In other words, the potential losses related to the future performance of the product are below low and average.

Investing in this product also entails risks that are materially relevant but not included in the risk indicator:

- **Concentration risk:** The sub-fund's portfolio is largely composed of debt securities (any currency) whose interest payment and/or principal repayment depends on the development of inflation in a country or geographical region, which may make the portfolio particularly sensitive to the economic development of this zone.
- **Risks associated with derivative products:** The derivative products in the portfolio may be more volatile than the underlying instruments to which they relate, resulting in a decrease in the value of the portfolio.
- **Sustainability risk:** Environmental and/or social aspects are taken into consideration during the sub-fund's investment selection process. Nevertheless, the risk of sustainability remains. As a result, the sub-fund may have greater exposure to issuers that have a negative sustainability impact.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product and/or a suitable benchmark over the last 10 years.

What happens if DPAM is unable to pay out?

The assets of the sub-fund are held with the Custodian and maintained separate from the other assets held by the Custodian.

In the event of a default by DPAM or any other sub-fund of the SICAV, neither of them may use the funds of the product to pay their debts.

However, your investment is not protected by an indemnification or guarantee mechanism.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

If you change sub-funds, you will pay any difference between the marketing fee for the sub-funds in question.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year, you would get back the amount that you invested (0 % annual return)
- the other holding periods we have assumed the product performs as shown in the moderate scenario
- that EUR 10,000 is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 2,59% before costs and 1,05% after costs.
