What is this product?

Distribution share of a sub-fund of DPAM B, a public SICAV under Belgian law. The shares of the sub-fund are distribution shares, which give right to a dividend. All income earned by the product can be distributed.

Duration

Indefinite. This product does not have a fixed maturity date.

Objectives

Objective: The objective of the sub-fund is to obtain as high a return as possible by investing mainly in American equities. The index is tracked using a passive investment management strategy investing physically and non-synthetically in all securities in the index or a representative sample of these securities, holding each security in a proportion approximately identical to its weight in the index. Each sector is represented in a proportion approximately identical to its weight in the index. The tracking error (standard deviation from the benchmark) is around 1.5%. This is a passively managed sub-fund, which means that the portfolio manager aims to replicate the performance of a benchmark.

Investment policy: The sub-fund invests mainly in equities (and other analogous transferable securities) of American companies, warrants, convertible bonds, subscription rights and, on an ancillary basis, cash and cash equivalents.

Derivative products: The sub-fund may, on an optional basis, use derivatives such as options and/or futures contracts ("futures" and/or "forwards") in order to achieve the investment objectives and/or for risk hedging purposes (hedging or exposure of/to interest rate and credit risks).

Benchmark: MSCI USA Net Return.

Subscription/Redemption:You can exchange your shares in this sub-fund for shares in another sub-fund. For more information on this subject, please refer to the information in the prospectus under the heading "Information about the shares and trading of the shares".

Intended Retail Investor

This product is intended for investors with an investment horizon of 6 years meet the criteria for access to this share class described in the prospectus and that:

- have sufficient knowledge and experience in the markets for equities and funds, and understand the risks of the product
- are seeking exposure to the equity markets of American companies by broadly replicating an index
- are interested in an investment without a sustainable investment objective
- can suffer a loss of more than 20% per year

DPAM B is an undertaking for collective investment in transferable securities incorporated in Belgium (the Home Member State of the SICAV), which complies with the requirements of Directive 2009/65/EC and which is subject to prudential supervision by the FSMA.

In accordance with the applicable legal provisions, the assets of the subfund are segregated from the assets of the other sub-funds of the SICAV, which means that the rights of the investors and other creditors of this subfund are limited to the assets thereof.


The prospectus and periodic reports are drawn up for all the sub-funds of the $\ensuremath{\mathsf{SICAV}}.$

What are the risks and what could I get in return?

Risk Indicator

The risk indicator assumes that you will hold the product for 6 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will

lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. In other words, the potential losses related to the future performance of the product are between average and high.

Investing in this product also entails risks that are materially relevant but not included in the risk indicator:

- Concentration risk: As the portfolio is mainly composed of US securities, it is likely to be more specifically exposed to the economic development of this sector and area.
- Sustainability risk: The sub-fund's main objective is to track the performance of its index. As a result, the sub-fund may have greater exposure to companies that have a negative sustainability impact.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product and/or a suitable benchmark over the last 11 years.

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. These figures do not take into account your personal tax situation, which may also affect the amounts you will receive.

What happens if DPAM is unable to pay out?

The assets of the sub-fund are held with the Custodian and maintained separate from the other assets held by the Custodian.

In the event of a default by DPAM or any other sub-fund of the SICAV, neither of them may use the funds of the product to pay their debts.

However, your investment is not protected by an indemnification or guarantee mechanism.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

If you change sub-funds, you will pay the total entry and exit fees for the sub-funds in question.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year, you would get back the amount that you invested (0 % annual return)
- the other holding periods we have assumed the product performs as shown in the moderate scenario
- that EUR 10,000 is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 13,98% before costs and 13,33% after costs.

How long should I hold it and can I take money out early?

The recommended holding period is 6 years.

You can sell your shares in the sub-fund at any time. The decision to exit before the end of the recommended holding period may have a negative impact on the performance and risk profile of your investment.
