### What is this product?

**Type** Accumulation shares (shares for which income and capital growth are retained in the share price) of a sub-fund of a SICAV, a regulated open-ended fund whose sub-funds are independent from a liability point of view.

### Investment objectives and policy

**Objective(s)** To increase the value of your investment over the long term by replicating the performance of the benchmark index.

**Benchmark(s)** MSCI ACWI SRI Net Return, an index that takes ESG factors into account. Usage: index replication.

**Investment policy** The sub-fund invests mainly in equities from around the world.

The sub-fund may use derivatives to hedge against market fluctuations and reduce costs, and also to generate additional income.

**Investment process** As part of the passive management of the sub-fund, the manager uses an index strategy that aims to replicate the composition and performance of the benchmark index.

**ESG approach** The manager is required to invest in the securities making up the index.

**SFDR Category** Article 8+.

### What are the risks and what could I get in return?

#### Risk indicator



The risk indicator assumes that you keep the product for at least **6 years**. The actual risk can vary significantly if you cash in before maturity and you may get back less.

The risk indicator is designed to help you compare the risks of investment products. It uses the required calculation methodology, which includes market movements and the risk that the product manufacturer cannot pay out as required. The risk indicator is not guaranteed and may change over time.

## Performance Scenarios

The unfavorable, intermediate and favorable scenarios presented represent examples using the best and worst performance, as well as the average performance of the product over the past 11 years. The stress scenario shows what you might get back in extreme market circumstances. The markets could evolve very differently in the future.

Unfavorable scenario: this type of scenario occurred for an investment between 22/11/2021 and 29/12/2023.

Intermediate scenario: this type of scenario occurred for an investment between 30/09/2014 and 30/09/2020.

Favorable scenario: this type of scenario occurred for an investment between 31/01/2014 and 31/01/2020.

## What happens if Degroof Petercam Asset Services S.A. is unable to pay out?

The sub-fund's assets are segregated from those of the other sub-funds in the SICAV and from Degroof Petercam Asset Services S.A., the product manufacturer and management company of the sub-fund. Even if it were to fail, the product manufacturer could not use the sub-fund's assets to pay its debts.

The only scenario under which an investor could incur a loss is by selling shares at a time when they are worth less than what the investor paid.

## Costs over time
