## What is this product?

#### Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

#### Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

#### Objectives

The investment objective of the East Capital China A-Shares sub-fund is to provide long-term capital growth through exposure to Chinese companies.

The sub-fund will invest at least 75% of its assets in equity or equity-related securities (such as, but not limited to, ADRs and GDRs) of companies domiciled in the People's Republic of China or that exercise a significant part of their economic activity there.

The sub-fund may invest directly up to 100% of its net assets in China A-Shares through the Shanghai-Hong Kong Stock Connect and/or through any similar acceptable securities trading and clearing linked program developed between Hong Kong Exchanges and Clearing Limited and the Shenzhen Stock Exchange.

Exposure to issuers domiciled in the People's Republic of China may also be achieved, inter alia, by investing in China B-Shares, China H-Shares as well as through UCITS eligible structured products such as participatory notes and/or equity-linked notes.

**Benchmark:** The portfolio is actively managed on a discretionary basis with reference to a benchmark. While the product compares its performance against the MSCI China A Onshore Index (Total Return Net), it does not try to replicate this benchmark and freely selects the securities that it invests in. The deviation

with this benchmark can be significant.

#### Intended retail investor

This fund may not be appropriate for investors who plan to withdraw their money within 5-10 years.

#### Other information

**Depositary:** Skandinaviska Enskilda Banken. AB (publ) – Luxembourg Branch

**Dividend income:** This class is a capitalisation class meaning that income is reinvested.

**Conversion right:** The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

**Segregation:** The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

## What happens if East Capital is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depository Skandinaviska Enskilda Banken. AB (publ) – Luxembourg Branch. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?
