## What is this product?

### Type

The product is a share class of the sub-fund Franklin Global Multi-Asset Income Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

### Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

### Objectives

#### Investment Objective

The Fund, which pursues an actively managed investment strategy, is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to earn income and to increase the value of its investments over the medium to long term by investing in a wide range of asset classes and geographic regions to support a steady level of annual distribution with at least 50% of the annual distribution deriving from the income generated by its portfolio.

#### Investment Policy

The Fund intends to manage its portfolio with half of the price fluctuation of global equity markets, but there is no guarantee that the Fund will achieve these targets.

The Fund invests worldwide in (i) equity securities issued by companies of any size which may be involved in mergers, liquidations or other major corporate transactions and (ii) debt securities of any quality (including lower-quality such as non-investment grade securities or securities in default) issued by governments, government-related entities and corporations.

The Fund can invest to a lesser extent in (i) alternative investments (such as commodities and property) achieved indirectly through eligible derivative instruments, (ii) structured products and (iii) up to 10% in units of mutual funds.

The Fund can use derivatives for hedging, efficient portfolio management and/or investment purposes.

The Fund may hold significant amounts of bank deposits, money market instruments or money market funds due to the use of derivatives or in order to achieve its investment goals and for treasury purposes.

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

**Benchmarks:** MSCI All Country World Index (used for volatility measurement purposes), 50% Bloomberg Multiverse (Hedged in EUR) + 50% MSCI All Country World Index (used for performance comparison purposes). The benchmarks are used solely for volatility measurement purposes and as a reference for Investors to compare against the Fund's performance. The Fund is not obliged to hold any of the benchmarks constituents and may indeed invest up to 100% of its net assets outside these benchmarks.

#### Share Class Policy

For the distribution share class shown in this document, dividend income is distributed to shareholders.

#### Processing of subscription and redemption orders

You may request the sale of your shares on any Dealing Day (as defined in the current prospectus of the Fund).

#### Intended retail investor

The Fund may appeal to investors looking to maximise their investment return with a combination of income and capital appreciation by obtaining exposure to a wide range of equity and debt securities worldwide as well as derivatives and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who have an some knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

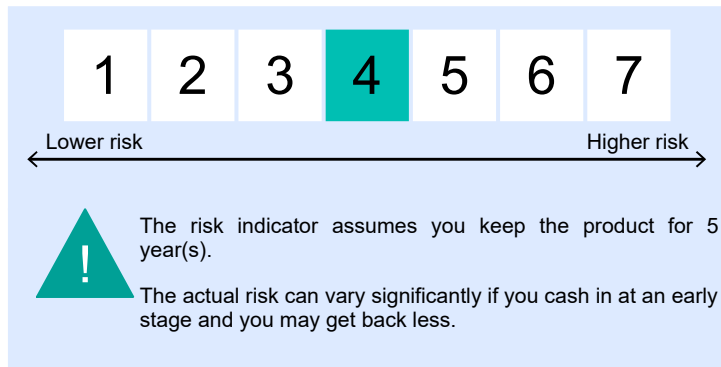

## What are the risks and what could I get in return?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

## What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- EUR 10,000 is invested

### Recommended holding period: 5 year(s)

This Fund has no minimum required holding period. We consider that the 5 year recommended holding period is appropriate because the Fund is designed for long-term investment. You may sell your shares on any dealing day. The value of your investments may go down as well as up irrespective of the period you are holding your investments, depending on such factors as the performance of the Fund, movements in stock and bond prices, and conditions in financial markets generally.
