What is this product?

Type

The product is a share class of the sub-fund Franklin Income Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund aims to earn income and, secondarily, to increase the value of its investments over the medium to long term.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

- equity and equity-related securities (including equity-linked notes) issued by companies located in, or doing significant business in, the U.S.
- debt securities of any quality (including lower quality) issued by corporations and governments

The Fund can invest to a lesser extent in:

- equity and debt securities traded in the U.S. and issued by corporations located anywhere in the world (limited to 25% of assets)
- equity or debt securities issued by corporations that entitle the holder to receive equity or debt securities of another corporation located anywhere in the world (limited to 25% of assets)
- derivatives for hedging, efficient portfolio management and/or investment purposes

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

The investment team uses in-depth analysis to select individual securities that it believes are undervalued and will provide the best opportunities for income and increased value over the long term.

The benchmark of the Fund is the Linked Blended 50% MSCI USA High Dividend Yield Index + 25% Bloomberg High Yield Very Liquid Index + 25% Bloomberg US Aggregate Index. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

Share Class Policy

For the distribution share class shown in this document, dividend income is distributed to shareholders.

Processing of subscription and redemption orders

You may request the sale of your shares on any Dealing Day (as defined in the current prospectus of the Fund).

Intended retail investor

The Fund may appeal to investors looking to maximise income while maintaining prospect for capital appreciation by obtaining exposure to a wide range of equity and debt securities of issuers primarily located in the U.S. and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

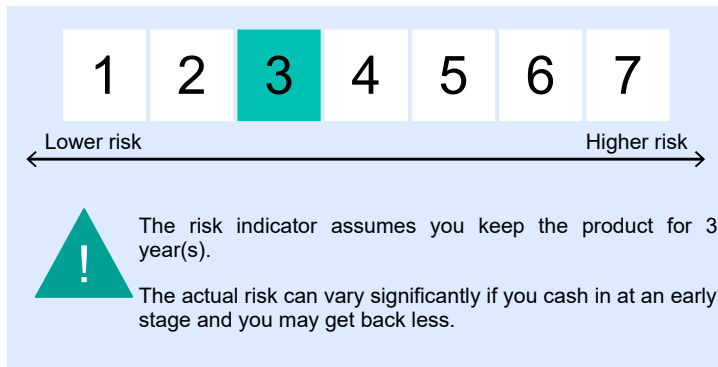

What are the risks and what could I get in return?

Risk Indicator

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- HKD 90,000 is invested

This Fund has no minimum required holding period. We consider that the 3 year recommended holding period is appropriate because the Fund is designed for medium-term investment.
