What is this product?

The product is a share class of the sub-fund Templeton Global Income Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS. Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Investment Objective

The Fund aims to maximise current income and to increase the value of its investments over the medium to long term.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

• debt securities of any quality (including lower quality and securities in default) issued by governments, government-related entities and corporations located in any country, including emerging markets

• equity securities issued by corporations located in any country

The Fund can invest to a lesser extent in:

Mainland China through the Bond Connect or directly (less than 30% of assets)

• Chinese A-Shares, equity securities of Chinese companies listed in Mainland China (limited to 10% of assets)

• units of other mutual funds (limited to 10% of assets)

• debt securities of supranational entities, such as the European Investment Bank

The Fund can use derivatives for hedging, efficient portfolio management and/or investment purposes.

In choosing equity securities, the investment team looks for those that appear to offer attractive dividends as well as the potential for long-term increase in value. In choosing debt securities, the investment team seeks to

The Fund is suitable for investors who have an some knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

Costs over Time
