What is this product?

Type

The product is a share class of the sub-fund Franklin Shariah Global Multi-Asset Income Fund (the "Fund") which is part of Franklin Templeton Shariah Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

The primary characteristic of a Shariah fund is its compliance with Shariah guidelines based on the principles of Islamic finance. A Shariah fund is required to appoint a Shariah supervisory board which independently ensures that the fund also meets such Shariah guidelines in the management of all of its assets. The Fund aims to earn income and, secondarily, to increase the value of its investments over the medium to long term.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

- Shariah-compliant equity securities (under normal market conditions, no more than 75% of the Fund's assets) and Shariah-compliant debt securities, including Sukuk, of any quality (including lower quality securities such as non-investment grade securities) and of any maturity, issued by governments, government-related entities, supranational entities and corporations located in developed and developing countries (investments in below investment grade is limited to 20% of the Fund's assets)

The Fund can invest to a lesser extent in:

- debt securities of companies that are, or are about to be, involved in reorganisations, financial restructurings, or bankruptcy and defaulted debt securities (limited in aggregate to 10% of assets)
- units of other mutual funds and exchange-traded fund (limited to 10% of assets)
- structured products, and derivatives in accordance with the Shariah guidelines
- certificates issued typically by a bank or a trust company that give their holders the right to receive securities issued by a foreign or domestic company (Depositary Receipts)

- alternative investments (such as commodities and property)

- Chinese A-Shares (equity securities of Chinese companies listed in Mainland China) and China B-Shares (limited in aggregate to 10% of assets)

The Fund may shift its investments from one asset class to another based on the Investment Manager's analysis of the market environment.

The investment team uses in-depth analysis to select individual securities that it believes are undervalued and will provide the best opportunities for income and increased value over the long term.

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

The benchmark of the Fund is the Blended 60% MSCI AC World Islamic-NR + 40% Dow Jones Sukuk Index. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

Processing of subscription and redemption orders

You may request the sale of your shares on any Luxembourg business day.

Intended retail Investor

The Fund may appeal to investors looking to capital appreciation by obtaining exposure to Shariah-compliant equity and equity-related securities of corporate issuers worldwide as well as American, European, and Global Depository Receipts and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have knowledge and/or experience of Shariah-compliant securities and financial markets with the understanding that they may not get back the full amount invested in the Fund.

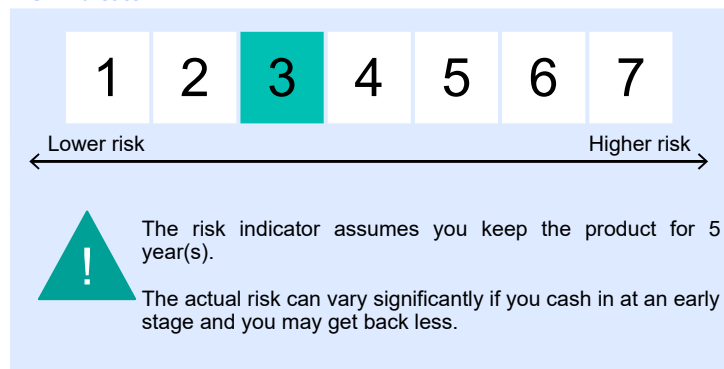

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario

Recommended holding period: 5 year(s)

This Fund has no minimum required holding period. We consider that the 5 year recommended holding period is appropriate because the Fund is designed for long-term investment.
