GKB (CH) Obligationen CHF ESG B is a unit class of the subfund GKB (CH) Obligationen CHF ESG (hereinafter "fund"), a subfund in the umbrella fund GKB (CH). The fund is managed by Swisscanto Fund Management Company Ltd., Zurich. The Asset Manager: Graubündner Kantonalbank.

## **Objectives and investment policy**

The fund's primary investment objective is to generate current income and preserve capital over the long term, while taking into consideration the asset manager's sustainability approach.

#### Important features:

The fund invests in Swiss franc-denominated fixed or variable-rate bonds and other debt securities in the investment grade range as well as in other investments permitted under the fund contract. The sustainability approach applied by the asset manager is explained in more detail in the prospectus.

Derivatives may be used for achieving the investment objective.

Fund units are issued and redeemed basically on every bank business day in Switzerland.

Earnings and profits of the unit class are distributed.

#### Additional important information:

The use of derivatives equates to neither leveraging nor short selling with regard to the fund assets.

Recommendation on holding period: this fund is appropriate for investors with a medium-term investment horizon (three to five years) or a longer-term investment horizon.


