What is this product?

Type The Company is an open-ended umbrella investment company with variable capital incorporated with limited liability under the laws of Ireland, registered number 373807.

Product objectives The Fund's objective is to seek long term appreciation through a combination of capital growth and income.

Investment approach The Fund will invest in medium to long term Investment approach The Fund will invest in medium to long term international debt securities (such as notes, bills, bonds, commercial paper, certificates of deposit and floating rate notes), in various currencies primarily listed on Recognised Markets in major financial markets. These securities will be issued by governments, institutions and corporations in both developed and developing markets although not more than 20% of the Fund's net assets will be invested in developing markets. The securities will typically be of investment grade (Baa or above by Moody's or BBB or above by Standard and Poor's or equivalent credit rating) but up to 20% of the Fund's net assets may be invested in lower quality securities. The Fund aims to identify the fixed income assets that will best perform in the prevailing macro-economic environment thus rotating through all credit sectors, maturities and geographies. Securities are selected by a quantitative screen which identifies geographies. Securities are selected by a quantitative screen which identifies the cheapest bonds for a given credit quality and maturity.

Benchmark The Fund's benchmark is the BofA Merrill Lynch 1-10 Year Global Corporate Index and may be used for comparative purposes only. The Fund is actively managed and as such does not seek to replicate its benchmark index, but instead may differ from the performance benchmark in order to achieve its objective. The sub-investment manager is not constrained by the benchmark in the selection of investments and may use its discretion to invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities.

Redemption policy Shares in the Fund can be bought and sold daily (every Business Day of the Fund). Shareholders may request the repurchase of shares on any Redemption Day through various communication methods, and such requests are generally irrevocable unless otherwise approved. Redemption requests are subject to certain conditions, including the completion of necessary documentation and compliance with anti-money laundering procedures. Redemption fees will not be levied by the Company, however charges of this nature may be levied by third party nominees, distributors or intermediaries. distributors or intermediaries.

Distribution policy Accumulating shares do not pay dividends. The annual result is capitalized (or reinvested). Income shares pay a dividend, insofar as the performance of the fund allows.

The Company may repurchase all shares at the determined repurchase price on the specified redemption day by providing shareholders with a notice period of four to twelve weeks.

Recommended holding period: 3 Years
