a sub-fund of Nomura Funds Ireland plc (the "Company")

This product is manufactured by Bridge Fund Management Ltd. The Fund is authorised in Ireland and is approved as an Undertaking for Collective Investment in Transferable Securities ("UCITS") by the Central Bank of Ireland. What is this product?

Type

Class A USD is a share class of the Fund, a sub-fund of the Company, which is an Irish UCITS variable capital umbrella investment company with segregated liability between sub-funds authorised by the Central Bank of Ireland.

Term

This product has no fixed term. The product may be liquidated under limited circumstances as detailed in the prospectus.

Objectives

Any income the Fund generates will be accumulated and reinvested on behalf of investors.

The Fund aims to achieve capital growth by investing in a relatively concentrated, global portfolio of businesses with a positive impact on the sustainable development of society.

The Fund will invest primarily in company shares and similar investments. The Fund may invest up to 30% of its net assets in emerging market countries at any given time. The investment manager has discretion when deciding which investments to hold within the Fund and uses a highly disciplined investment process. This focuses on individual businesses trading at discounted valuations and that demonstrate ethical work practices, socially responsible corporate governance practices, and that engage with the wider community. As well as a detailed analysis of each

company's fundamentals the investment manager will also use screening tools to help focus on those companies that could be attractive investments. The Fund may use derivatives (futures and forward currency contracts) for efficient portfolio management and/or hedging purposes, subject to the conditions and limits of the Central Bank of Ireland.

The Fund is considered to be actively managed in reference to the index (MSCI All Country World Index) by virtue of the fact that it uses the index for performance comparison purposes. Certain of the Fund's securities may be components of and may have similar weightings to the index. However, the Fund may deviate materially from the index and the investment manager may use its discretion to invest in companies or sectors not included in the index.

Intended retail investor

The Fund is intended for retail and institutional investors. The Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The Fund is suitable for investors seeking long-term capital growth and who are prepared to accept a moderate level of volatility.

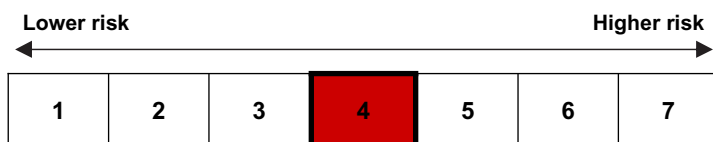
Other Information

What are the risks and what could I get in return?

Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator (SRI) assumes you keep the product for a minimum of 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the Fund to pay you.

Be aware of currency risk. If you choose a foreign currency share class you will be exposed to currency risk and your final return will depend on the exchange rate between the foreign currency and your local currency. Currency hedged share classes aim to deliver a return that is as close as possible to the base currency performance of a fund, by reducing the effect of exchange rate movements between the base currency and the hedged currency. However, these techniques may not be fully effective in completely removing the exchange rate risk.

Performance Scenarios

Cost over time

We have assumed that in the first year you would get back the amount that you invested (0 % annual return), for the other holding period that the product performs as shown in the moderate scenario. and that your USD 10 000,00 has been invested.
