What is this product?

Type

This is an open ended UCITS fund.

Term

The fund is established for an unlimited period. In certain circumstances the fund may be unilaterally terminated in accordance with legal requirements.

Investment objective

The fund aims to provide a positive return after fees have been deducted over a three year period by providing exposure to insurance risks that meet the manager's sustainability criteria.

The fund is actively managed and will invest globally in a diversified portfolio providing exposure to insurance risks. These include insurancelinked securities and financial derivative instruments that are exposed to catastrophe risks denominated in various currencies.

The fund invests:

- at least 80% of its assets in investments linked to natural catastrophe and/or life risks:

- at least 50% of its assets in investments linked to meteorological risks;

- at least 5% of its assets in investments that are designed to address the unavailability of affordable insurance cover against natural catastrophes.

The fund may hold cash (subject to the restrictions provided in appendix I in the fund's prospectus) and invest in money market investments and liquid assets other than cash. The fund will not invest more than 10% into funds

Derivatives may be used to achieve the investment objective and to reduce risk or manage the fund more efficiently.


The fund is valued with reference to the net asset value of the underlying assets.

The fund maintains a positive absolute sustainability score, based on the manager's rating system.

The fund does not directly invest in certain risk classes, activities, industries or groups of issuers above the limits listed under "Sustainability-Related Disclosure" on the fund's webpage, accessed via www.schroders.com/en/lu/private-investor/gfc.

The fund invests in investments issued by issuers that have good governance practices, as determined by the manager's rating criteria. The manager may also engage with issuers or transaction sponsors held by the fund to challenge identified areas of weakness on sustainability issues. Benchmark: The fund's performance should be assessed against its target benchmark, being to provide a positive return over a three year period. The target benchmark has been selected because the target return of the fund is to deliver the return of that benchmark as stated in the investment objective. The investment manager invests on a discretionary basis and is not limited to investing in accordance with the composition of a benchmark. The fund is not expected to replicate the performance of any benchmark.

Currency: The sub-fund currency is USD. The share class currency is CHF. Dealing Frequency: You can buy and sell shares fortnightly on the 2nd and 4th Friday in a month (or the next business day if the Friday is not a business day) and on the last business day in a month.

Distribution Policy: This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.

Intended retail investor

The fund may be suitable for investors who have a medium to longer term investment horizon and who are seeking diversification by investing in an asset class whose performance is not linked to other financial assets. In addition, the investor has a risk tolerance high enough to absorb potential losses invested following the occurrence of extreme insurance disasters. The fund is not intended for retail investors; it is intended for sophisticated investors. This investment should form part of a varied investment portfolio.

What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?

The fund's assets are held in safekeeping by its depositary, so the fund's ability to pay out would not be affected by the insolvency of Schroder Investment Management (Europe) S.A. In addition, the fund's assets are segregated from the depositary's assets, which limits the risk of the fund suffering loss in case of default or insolvency of the depositary or someone acting on its behalf. However in the event of any loss, there is no compensation or guarantee scheme in place which may offset such loss.

What are the costs?

Costs over time
